#### <u>ORDER</u>

Now comes the Virginia Board of Nursing ("Board") and Cathy Culbertson, R.N., as evidenced by the signature affixed below, enter into this Order affecting the license of Ms. Culbertson to practice professional nursing in the Commonwealth of Virginia.

## **FINDINGS OF FACT**

After consideration of the evidence and statements concerning the allegations, the Committee makes the following Findings of Fact:

- 1. Cathy Culbertson, R.N., holds license number 0001-090199 issued by the Virginia Board of Nursing.
- 2. By an Order entered September 10, 2008, Ms. Culbertson was subject to certain terms and conditions. One of the terms of this Order was Ms. Culbertson's compliance with all terms and conditions of her contract with the Health Practitioners' Intervention Program (currently known as the Health Practitioners' Monitoring Program, hereafter "HPMP"), pursuant to Chapter 25.1 of Title 54.1 of the Code of Virginia (1950), as amended, and 18 VAC 76-10-10, et seq., of the Regulations Governing the HPMP.
- 3. Ms. Culbertson has complied with all terms and conditions of the above Order; and, as confirmed by letter dated December 17, 2010, from the Health Practitioners' Monitoring Program Committee, Ms. Culbertson has successfully completed her contract with the HPMP.

## CONCLUSIONS OF LAW

The Committee concludes that Cathy Culbertson, R.N., has met the requirements of the Code of Virginia (1950), as amended, and the Regulations of the Board of Nursing, and the Order entered September 10, 2008, and this matter is properly before the Committee.

### <u>ORDER</u>

WHEREFORE, on the basis of the foregoing Findings of Fact and Conclusions of Law it is hereby ORDERED that the terms and conditions placed on the license of Cathy Culbertson, R.N., to practice professional nursing in the Commonwealth of Virginia, be, and are hereby, TERMINATED.

Pursuant to § 54.1-2400(10) of the Code of Virginia (1950), as amended, this Order shall become final thirty (30) days after service unless a written request for a hearing before the Board is filed with Jay P. Douglas, R.N., M.S.M., C.S.A.C., Executive Director, Board of Nursing. In the event that this decision is served by mail, three (3) days shall be added to the thirty (30) day period.

Pursuant to § 2.2-4023 of the Code of Virginia, the signed original of this Order shall remain in the custody of the Department of Health Professions as a public record and shall be made available for public release, inspection and copying upon request.
