

**VIRGINIA:**

**BEFORE THE BOARD OF NURSING**

**ORDER**

In accordance with §§ 2.2-4019, 2.2-4021 and 54.1-2400(10) of the Code of Virginia (1950), as amended ("Code"), an informal conference was conducted on behalf of the Board of Nursing ("Board") on November 4, 2014, in Henrico County, Virginia. Ms. Wilson was present and was represented by Jennifer T. Atkinson, Esq. Nancy Durrett, R.N., M.S., serving as Agency Subordinate for the Board, submitted a Recommended Decision for consideration.

On January 28, 2015, a quorum of the Board met to receive and act upon the Recommended Decision of the Agency Subordinate. Ms. Wilson was not present nor was she represented by legal counsel. Ms. Wilson submitted written comments/objections.

Based upon its review of the Recommended Decision of the Agency Subordinate, the Board makes the following Findings of Fact and Conclusions of Law and issues the following Order.

**FINDINGS OF FACT**

1.       Sheryl Banks Wilson, C.N.A., was issued Certificate No. 1401-132420 to practice as a nurse aide in Virginia on September 15, 2009. The certificate is scheduled to expire on September 30, 2015.
2.       By letter dated August 18, 2014, the Board of Nursing sent a Notice of Informal Conference ("Notice") to Ms. Wilson notifying her that an informal conference would be held on September 9, 2014. The Notice was sent by certified and first class mail to 813 Ventnor Drive, Newport News, Virginia 23606, the address of record on file with the Board of Nursing. Ms. Wilson requested a continuance which was granted and the informal conference was rescheduled for November 4, 2014.

3. During the course of her employment with Riverside Home Health, Newport News, Virginia, in August or September, 2013, by her own admission Ms. Wilson accepted a loan of \$500.00 from the wife of her home care client.

4. The client's wife reported that Ms. Wilson repaid the loan in March, 2014. Ms. Wilson had provided care to this client for about five (5) years.

5. Ms. Wilson's employment at Riverside Home Health was terminated as a result of this incident.

6. Ms. Wilson was hired by Maxim Healthcare in March, 2014, but her employment was suspended when that company became aware of the disciplinary matter being considered by the Board of Nursing. The manager at Maxim stated that he would rehire Ms. Wilson once the disciplinary matter was resolved, as her performance at Maxim had been satisfactory.

7. Ms. Wilson reports she is currently not working as a C.N.A. She states she is doing volunteer work at a dentist's office.

#### **CONCLUSIONS OF LAW**

Finding of Fact No. 3 constitutes a violation of § 54.1-3007(5) of the Code and 18 VAC 90-25-100(2)(g) of the Regulations Governing Certified Nurse Aides.

#### **ORDER**

WHEREFORE, it is hereby ORDERED as follows:


1. Sheryl Banks Wilson, C.N.A., is hereby REPRIMANDED.
2. Ms. Banks shall maintain a course of conduct in her capacity as a nurse aide commensurate with the requirements of § 54.1-3000 *et seq.* of the Code and the Board of Nursing Regulations.

Pursuant to § 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody

of the Department of Health Professions as a public record, and shall be made available for public inspection and copying upon request.

Pursuant to Section 54.1-2400(10) of the Code, Ms. Banks may, not later than 5:00 p.m., on **March 9, 2015**, notify Jay P. Douglas, M.S.M., R.N., C.S.A.C., F.R.E., Executive Director, Board of Nursing, 9960 Mayland Drive, Suite 300, Henrico, Virginia 23233, in writing that she desires a formal administrative hearing before the Board. Upon the filing with the Executive Director of a request for the hearing, this Order shall be vacated.
