# <u>ORDER</u>

Pursuant to §§ 2.2-4019, 2.2-4021, and 54.1-2400(10) of the Code of Virginia (1950), as amended ("Code"), a Special Conference Committee ("Committee") of the Virginia Board of Nursing ("Board") met on June 6, 2007, in Henrico County, Virginia, to inquire into evidence that Ms. Kunkle may have violated certain laws and regulations governing nursing practice in Virginia. Ms. Kunkle was present and was represented by Cindy Billups, Esquire.

Upon consideration of the evidence, the Committee adopts the following Findings of Fact and Conclusions of Law:

## **FINDINGS OF FACT**

- 1. Jenny Kunkle was issued License No. 0001-153646 to practice professional nursing in the Commonwealth of Virginia on June 16, 1997. Said license is current.
- 2. Ms. Kunkle admitted to an investigator for the Department of Health Professions in an interview on October 27, 2006, that she took too much pain medication, had developed a dependence on pain medication, and had attended outpatient substance abuse treatment. At the informal conference, Ms. Kunkle acknowledged an addiction to narcotic pain medication.
- 3. Ms. Kunkle entered Williamsburg Place for inpatient substance abuse treatment on May 9, 2007, with a discharge date of June 7, 2007. She was scheduled to enter two additional months of inpatient treatment at the William Farley Center thereafter.
- 4. Ms. Kunkle signed a Participation Contract with the Health Practitioners' Intervention Program ("HPIP") on May 31, 2007.

- 5. Ms. Kunkle presented excellent performance evaluations and references.
- 6. No patient harm or diversion of drugs resulted from Ms. Kunkle's addiction to pain medication.

### **CONCLUSIONS OF LAW**

- 1. Finding of Fact No. 2 constitutes a violation of § 54.1-3007(6) of the Code..
- 2. Ms. Kunkle is properly enrolled in the Health Practitioners' Intervention Program.

## **ORDER**

On the basis of the foregoing, the Committee hereby ORDERS as follows:

- 1. The Committee shall TAKE NO ACTION at this time, contingent upon Ms. Kunkle's continued compliance with the HPIP, including entering into a Recovery Monitoring Contract ("Contract") when recommended by the HPIP and complying with all terms and conditions of the Contract with the HPIP for the period specified in the Contract.
- 2. This Order shall be applicable to Ms. Kunkle's multistate licensure privilege, if any, to practice professional nursing in the Commonwealth of Virginia. For the duration of this Order, Ms. Kunkle shall not work outside the Commonwealth of Virginia pursuant to a multistate licensure privilege without the written permission of the Virginia Board of Nursing and the Board of Nursing in the party state where Ms. Kunkle wishes to work. Any request for out of state employment shall be directed, in writing, to the Executive Director of the Board.
- 3. Any violation of the terms and conditions stated in this Order shall be reason for revoking the license of Ms. Kunkle, and an administrative proceeding shall be held to decide whether her license should be revoked. Ms. Kunkle shall be noticed to appear before the Board at such time as the Board is notified that:

a. She is not in compliance with the terms and conditions of the HPIP, or has been

terminated from participation in the HPIP;

b. There is a pending investigation or unresolved allegation against Ms. Kunkle

involving a violation of law or regulation or any term or condition of this Order; or

c. Ms. Kunkle has successfully completed the above-referenced period of participation in

the HPIP. However, upon receipt of Ms. Kunkle's participation in and compliance with the HPIP, the Board,

at its discretion, may waive Ms. Kunkle's appearance before the Board and conduct an administrative review

of this matter.

4. Ms. Kunkle shall maintain a course of conduct in her capacity as a professional nurse

commensurate with the requirements of § 54.1-3000 et seq. of the Code and the Board of Nursing

Regulations.

Pursuant to §§ 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in

the custody of the Department of Health Professions as public record and shall be made available for public

inspection or copying on request.
