**ORDER** 

In accordance with §§ 2.2-4019, 2.2-4021 and 54.1-2400(10) of the Code of Virginia (1950), as amended ("Code"), an informal conference was conducted on behalf of the Board of Nursing ("Board") on December 11, 2014, in Henrico County, Virginia. Sylvia McCorkle, C.N.A., was present and was not represented legal counsel. Nancy Durrett, R.N., M.S., serving as Agency Subordinate for the Board, submitted a Recommended Decision for consideration.

Based upon its review of the Recommended Decision of the Agency Subordinate, the Board makes the following Findings of Fact and Conclusions of Law and issues the following Order.

## FINDINGS OF FACT

- Sylvia McCorkle, C.N.A., was issued Certificate No. 1401-115594 to practice as a nurse aide in Virginia on August 26, 2006. The certificate is scheduled to expire on August 31, 2015.
- 2. Ms. McCorkle submitted an application for licensure by examination to practice practical nursing which was received by the Board on August 18, 2014.
- 3. By letter dated November 24, 2014, the Board of Nursing sent a Notice of Informal Conference ("Notice") to Ms. McCorkle notifying her that an informal conference would be held on December 11, 2014. The Notice was sent by United Postal Service and first class mail to 924 St. Johns Woods Drive, Richmond, Virginia 23225.
- 4. On August 1, 2014, Ms. McCorkle graduated from the Practical Nursing Program at J. Sargeant Reynolds Community College, Richmond, Virginia.

## **CONCLUSIONS OF LAW**

Ms. McCorkle meets the qualifications of § 54.1-3020 of the Code.

## <u>ORDER</u>

WHEREFORE, it is hereby ORDERED that the application of Sylvia McCorkle for licensure by examination to practice practical nursing is APPROVED. Upon successful completion of the NCLEX-PN examination, Ms. McCorkle shall be issued an unrestricted license to practice as a practical nurse in the Commonwealth.

Pursuant to § 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as a public record, and shall be made available for public inspection and copying upon request.

Pursuant to Section 54.1-2400(10) of the Code, Ms. McCorkle may, not later than 5:00 p.m., on February 25, 2015, notify Jay P. Douglas, M.S.M., R.N., C.S.A.C., F.R.E., Executive Director, Board of Nursing, 9960 Mayland Drive, Suite 300, Henrico, Virginia 23233, in writing that she desires a formal administrative hearing before the Board. Upon the filing with the Executive Director of a request for the hearing, this Order shall be vacated.
