**NOTICE OF HEARING**

Pursuant to §§2.2-4020, 2.2-4024(F), and 54.1-2400(11) of the Code of Virginia (1950), as amended ("Code"), Victoria Tarmoh, C.N.A., who holds Certificate No. 1401-125527 which expires on July 31, 2012, is hereby given notice that a formal administrative hearing will be held in the presence of a panel of the Board of Nursing. The hearing will be held on January 23, 2012, at 10:00 a.m., at the offices of the Department of Health Professions, Board of Nursing, Perimeter Center, 9960 Mayland Drive, Suite 201, Henrico, Virginia 23233, at which time Ms. Tarmoh will be afforded the opportunity to be heard in person or by counsel.

At the hearing, Ms. Tarmoh has the following rights, among others: the right to representation by counsel; the right to have witnesses subpoenaed and to present witnesses on her behalf; the right to present documentary evidence; and the right to cross-examine adverse witnesses. If Ms. Tarmoh desires any witnesses to appear on her behalf, she must notify the Director of Administrative Proceedings, Department of Health Professions, 9960 Mayland Drive, Suite 300, Henrico, Virginia 23233, in accordance with the Instructions for Requesting Subpoenas.


The purpose of the hearing is to inquire into evidence that Victoria Tarmoh, C.N.A., may have violated certain laws and regulations governing certified nurse aide practice in Virginia, as more fully set forth in the Statement of Particulars below.

**STATEMENT OF PARTICULARS**

The Board alleges that Victoria Tarmoh, C.N.A., may have violated §54.1-3007(2), (5) and (8) of the Code and 18 VAC 90-25-100(2)(e) of the Regulations Governing Certified Nurse Aides in that, on or about July 30, 2010, during the course of her employment with Fairfax Nursing Center, Fairfax, Virginia, Ms. Tarmoh failed to follow a resident's plan of care, which required the resident have a two-person transfer, by transferring the resident from her wheelchair to her bed unassisted. Resident A fell to the floor.

If the Board finds that Victoria Tarmoh, C.N.A., is in violation of the above allegation(s) and §54.1-3007(8) of the Code, the Board shall make a Finding of Abuse, Neglect, or Misappropriation of patient property, which will be entered in the Virginia Nurse Aide Registry pursuant to 42 CFR §483.156(b)(2) and (c)(1)(iv)(D) of the Code of Federal Regulations. According to 42 CFR §483.13(c)(1)(ii)(B), such a finding will prohibit Ms. Tarmoh's future employment as a certified nurse aide in any long term care facility which receives Medicare or Medicaid reimbursement.
