AMENDED ORDER

The Virginia Board of Nursing ("Board") issues the following Order affecting the license of Andrew

H. Gorski, R.N., to practice professional nursing in Virginia.

The Board adopts the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

1. Andrew H. Gorski, R.N., was issued License No. 0001-234410 to practice professional

nursing by the Virginia Board of Nursing on November 2, 2011. Said license is set to expire on October 31,

2015. Mr. Gorski's primary state of residence is Virginia.

2. By Order of the Board of Nursing entered January 6, 2015 ("Board's Order"), Mr. Gorski was

ordered to undergo an evaluation by a mental health and chemical dependency specialist satisfactory to the

Board.

3. The Board's Order required Mr. Gorski to have a written report of the evaluation including

diagnosis recommended course of therapy, prognosis, and any recommendations sent to the Board within 90

days after the date that the Order was entered.

4. On February 12, 2015, the Board approved an individual to perform the evaluation.

5. On March 16, 2015, the Board received the report, and an amended report with

recommendations was received by the Board on March 23, 2015.

6. The report stated that Mr. Gorski did not appear to have a substance abuse disorder, and the

results ruled out chemical dependency and post-traumatic stress disorder, but found generalized anxiety

disorder, mild to moderate, recommended counseling for treatment, and stated that the prognosis was positive.

7. On April 7, 2015, Mr. Gorski's compliance case manager notified the Board that Mr. Gorski had complied with the terms of the Board Order.

## **CONCLUSION OF LAW**

Andrew H. Gorski has complied with the terms and conditions of the Board's Order.

## <u>ORDER</u>

WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Order, and in lieu of further proceedings, hereby ORDERS that Mr. Gorski has satisfied the terms of the Board's Order and that NO FURTHER ACTION SHALL BE TAKEN.

Pursuant to §§ 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as public record and shall be made available for public inspection or copying upon request.
