CONSENT ORDER

The Virginia Board of Nursing ("Board") and Sarah Blalock, as evidenced by her signature hereto, enter into the following Consent Order affecting Ms. Blalock's application for registration by examination to practice as a medication aide in Virginia.

The Board adopts the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

1. Sarah Blalock submitted an application for registration by examination as a medication aide, which was received by the Board on October 30, 2014.
2. On October 24, 2012, Ms. Blalock was convicted in the County Court of McLellan County, Texas, of theft, a misdemeanor involving moral turpitude.

CONCLUSIONS OF LAW

1. Finding of Fact No. 2 constitutes a violation of § 54.1-3007(4) of the Code of Virginia (1950), as amended ("Code").
2. Ms. Blalock otherwise meets the requirements of § 54.1-3042 of the Code.

CONSENT

Sarah Blalock, by affixing her signature hereon, agrees to the following:

1. She has been advised to seek advice of counsel prior to signing this document;
2. She acknowledges that without her consent, no legal action can be taken against her except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) *et seq.* of the Code;

3. She acknowledges that she has the following rights, among others: the right to an informal fact finding conference before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against her;
4. She waives all such right to an informal conference;
5. She admits to the Findings of Fact and Conclusions of Law contained herein and waives her right to contest such Findings of Fact and Conclusion of Law in any subsequent proceeding before the Board;
6. She consents to the entry of the following Order affecting her application for registration by examination as a medication aide in Virginia.

ORDER

WHEREFORE, it is hereby ORDERED as follows:

1. The application of Sarah Blalock for registration by examination as a medication aide is APPROVED. Upon successful completion of the Medication Aide examination, Ms. Blalock shall be issued a registration to practice as a medication aide in the Commonwealth.
 2. Ms. Blalock is hereby REPRIMANDED.
 3. Ms. Blalock shall maintain a course of conduct in her capacity as a medication aide commensurate with the requirements of § 54.1-3000 et seq. of the Code and the Board of Nursing Regulations.
- Pursuant to §§ 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as public record and shall be made available for public inspection or copying upon request.
