NOTICE OF HEARING

Pursuant to §§ 2.2-4020, 2.2-4024(F), and 54.1-2400(11) of the Code of Virginia (1950), as amended

("Code"), Jamie L. Cale, L.P.N., who, prior to its suspension by the Board of Nursing ("Board") on June 12,

2015, held License No. 0001-063502, is hereby given notice that a formal administrative hearing will be held

in the presence of a panel of the Board. The hearing will be held on September 17, 2015, at 2:30 p.m., at the

offices of the Department of Health Professions, Board of Nursing, Perimeter Center, 9960 Mayland Drive,

Suite 201, Henrico, Virginia 23233, at which time Ms. Cale will be afforded the opportunity to be heard in

person or by counsel.

At the hearing, Ms. Cale has the following rights, among others: the right to representation by

counsel; the right to have witnesses subpoenaed and to present witnesses on her behalf; the right to present

documentary evidence; and the right to cross-examine adverse witnesses. If Ms. Cale desires any witnesses

to appear on her behalf, she must notify the Director of Administrative Proceedings, Department of Health

Professions, 9960 Mayland Drive, Suite 300, Henrico, Virginia 23233, in accordance with the Instructions

for Requesting Subpoenas.

The purpose of the hearing is to inquire into evidence that Ms. Cale may have violated certain laws

governing the practice of nursing and certain terms and conditions imposed on her as set forth in the Order of

the Board entered on December 12, 2014, as more fully set forth in the Statement of Particulars below.

STATEMENT OF PARTICULARS

The Board alleges that Ms. Cale may have violated § 54.1-3007(6) of the Code and Term No. 1 of the Board's Order entered December 12, 2014 ("Board's Order"), which stayed the suspension of her license contingent on her entry into and compliance with the Health Practitioners' Monitoring Program ("HPMP"), in that she was dismissed from the HPMP effective May 15, 2015. Further, Ms. Cale failed to comply with the terms of the HPMP in that on March 3, 2015, Ms. Cale received a positive EtS result for alcohol use, and on March 9, 2015, she received a positive EtG/EtS result for alcohol use. In addition, Ms. Cale resigned from HPMP verbally on March 16, 2015, and in writing on March 19, 2015, and she failed comply with the HPMP toxicology screening program from March 19, 2015 until the date of her dismissal.
