Dear Ms. Lassiter:

This letter is official notification that an informal conference of the Virginia Board of Nursing ("Board") will be held on **February 15, 2012, at 1:00 p.m.**, at the Department of Health Professions, Perimeter Center, 9960 Mayland Drive, Suite 201, Henrico, Virginia. In accordance with §§ 2.2-4019, 2.2-4021, and 54.1-2400(10) of the Code of Virginia (1950), as amended ("Code"), this informal conference will be held before an agency subordinate of the Board of Nursing. This informal conference will be convened as a public meeting pursuant to § 2.2-3700 *et seq.* of the Code. The agency subordinate will inquire into allegations that you may have violated certain laws and regulations governing practical nursing practice in Virginia.

Specifically:

1. You may have violated §§ 54.1-3007(3), (5) and (8) and 54.1-3008(A)(2) and (4) of the Code in that:

a. On or about November 30, 2006, your license to practice practical nursing expired and was renewed on or about January 9, 2007. From on or about December 1, 2006, to on or about January 8, 2007, you practiced nursing at Port Human Services, Greenville, North Carolina, without a valid license or multistate privilege.

b. On or about November 30, 2010, your license to practice practical nursing expired and was renewed on or about April 22, 2011. From on or about December 1, 2010, to on or about December 7, 2010, you practiced nursing at Metropolitan Community Health Services, Washington, North Carolina, without a valid license or multistate privilege.

2. You may have violated § 54.1-3007(2), (3) and (5) of the Code and 18 VAC 90-20-300(A)(2)(e) of the Regulations Governing the Practice of Nursing ("Regulations") in that on or about January 7, 2011, you presented an altered license to Metropolitan Community Health Services, with an expiration date of November 30, 2012.

3. You may have violated § 54.1-3007(1) of the Code and 18 VAC 90-20-300(A)(1)(b) of the Regulations in that on or about April 22, 2011, you renewed your license using a Virginia address as your address of record; however, on the applications for licensure by endorsement to North Carolina dated June 20, 2010, and February 11, 2008, you provided a North Carolina address as your address of record. Further, on or about August 12, 2011, you presented an investigator with the Department of Health Professions with a North Carolina driver's license as a form of identification.

In its deliberations, the agency subordinate may use the Sanction Reference Points System, as contained in the Sanction Reference Manual. The manual, which is a guidance document of the Board, may be accessed at <http://www.dhp.virginia.gov/nursing>. Please click on *Guidance Documents*, then select #90-7. You may also request a paper copy from the Board office by calling (804) 367-4515.

After consideration of all information, the agency subordinate may:

- If the agency subordinate finds that there is insufficient evidence to warrant further action or that the charges are without foundation, notify you by mail that your record has been cleared of any charge which might affect your right to practice nursing in the Commonwealth;
- Recommend findings of fact, conclusions of law and a sanction, to include a reprimand, placing you on probation with terms, suspension or revocation of your license, or imposing a monetary penalty pursuant to § 54.1-2401 of the Code.

Further, the agency subordinate may refer this matter for a formal administrative proceeding pursuant to § 2.2-4020 of the Code.

### **Board's Review of Agency Subordinate's Recommended Decision**

If you **appear in person or by counsel at the informal conference**, the recommendation of the agency subordinate will be presented to a quorum of the Board. The Board may accept or modify the recommendation, or reject the recommendation and move the case to formal hearing. If you do not agree with the decision of the Board, you have the right to a formal administrative hearing before the Board.

If you **fail to appear in person or by counsel at the informal conference**, the recommendation of the agency subordinate will be presented to a quorum of the Board. The Board may accept or modify the recommendation, or reject the recommendation. The Board's decision

regarding the agency subordinate's recommendation is a final order that can only be appealed to circuit court as provided by Rule 2A:2 of the Supreme Court of Virginia.

You have the right to information that will be relied upon by the agency subordinate in making a decision. Therefore, I enclose a copy of the documents that will be distributed to the agency subordinate, and will be considered when discussing the allegations with you and when deliberating upon your case. **These documents are enclosed only with the original notice sent by certified mail, which you may be required to claim at the post office. Please bring these documents with you to the informal conference.**

To facilitate this proceeding, you should submit five copies of any documents you wish the agency subordinate to consider to the Board of Nursing, Perimeter Center, 9960 Mayland Drive, Suite 300, Richmond, VA 23233, by February 8, 2012. Your documents may not be submitted by facsimile or email.


You may be represented by an attorney at the informal conference. If you obtain counsel, you should do so as soon as possible, because absent good cause to support a request for a continuance, the informal conference will be held on February 15, 2012. A request to continue this proceeding must state **in detail** the reason for the request and must establish good cause. Such request must be made, in writing, to me at the address listed on this letter and must be received by 12 noon on February 8, 2012. Only one such motion will be considered. Absent critical circumstances, such as personal or family illness, a request for a continuance after February 8, 2012 will not be considered.
