Ms. Woldemariam will be afforded the opportunity to be heard in person or by counsel.

At the hearing, Ms. Woldemariam has the following rights, among others: the right to representation

by counsel; the right to have witnesses subpoenaed and to present witnesses on her behalf; the right to

present documentary evidence; and the right to cross-examine adverse witnesses. If Ms. Woldemariam

desires any witnesses to appear on her behalf, she must notify the Director of Administrative Proceedings,

Department of Health Professions, 9960 Mayland Drive, Suite 300, Henrico, Virginia 23233, in accordance

with the Instructions for Requesting Subpoenas.

The purpose of the hearing is to inquire into evidence that Elsabet Woldemariam, L.P.N., may have

violated certain terms and conditions imposed on her as set forth in the Order of the Board entered on

December 9, 2011 ("Board's Order"), as more fully set forth in the Statement of Particulars below.

STATEMENT OF PARTICULARS

The Board alleges that:

1. Elsabet Woldemariam, L.P.N., may have violated Term No. 1(b) of the Board's Order, which

required her to inform the Board within ten days of the date in which she began or changed employment, or if any interruption in nursing practice occurred, and to provide the Board with the name and address of her employer(s), in that she failed to notify the Board of her employment with Knollwood Terrace, Washington, D.C., which she began in March 2010, until August 2012.

- 2. Ms. Woldemariam may have violated Term No. 1(c) of the Board's Order, which required her to inform her nursing employer(s) that the Board had placed her on probation and to provide the employer(s) with a copy of the Board's Order, in that she failed to provide Knollwood Terrace with a copy of the Board's Order.
- 3. Ms. Woldemariam may have violated Term No. 1(d) of the Board's Order, which required her to cause quarterly performance evaluations to be submitted to the Board, in that the Board has only received one evaluation regarding her performance at Knollwood Terrace, which was received in August, 2013.
- 4. Ms. Woldemariam may have violated Term No. 1(e) of the Board's Order, which required her to obtain the Board's approval of any nursing employment setting, in that she failed to obtain the Board's approval for her employment with Knollwood Terrace until July, 2013.
- 5. Ms. Woldemariam may have violated Term No. 1(f) of the Board's Order, which required her to submit quarterly Self-Reports to the Board beginning February 7, 2012, in that she did not submit the reports due on February 7, 2012 and June 30, 2012 until August 6, 2012.
