**ORDER**

Now comes the Virginia Board of Nursing ("Board") and Meagan Nozzarella, R.N., as evidenced by the signature affixed below, enter into this Order affecting the license of Ms. Nozzarella to practice professional nursing in the Commonwealth of Virginia.

**FINDINGS OF FACT**

After consideration of the evidence and statements concerning the allegations, the Committee makes the following Findings of Fact:

1. Meagan Nozzarella, R.N., was issued License No. 0001-191738 to practice as a professional nurse in the Commonwealth of Virginia. Said license expires on May 31, 2017.
2. By Order entered December 4, 2014 Ms. Nozzarella was made subject to certain terms and conditions. One of the terms of this Order was Ms. Nozzarella's compliance with all terms and conditions of her contract with the Health Practitioners' Monitoring Program ("HPMP"), pursuant to Chapter 25.1 of Title 54.1 of the Code of Virginia (1950), as amended, and 18 VAC 76-10-10, et seq., of the Regulations Governing the HPMP.
3. Ms. Nozzarella has complied with all terms and conditions of the above Order; and has successfully completed her contract with the HPMP.

**CONCLUSIONS OF LAW**

The Board concludes that Meagan Nozzarella, R.N., has met the requirements of the Code of Virginia (1950), as amended, and the Regulations of the Board of Nursing, and the Order entered December 4, 2014, and this matter is properly before the Board.


ORDER

WHEREFORE, on the basis of the foregoing Findings of Fact and Conclusions of Law it is hereby ORDERED that the terms and conditions placed on the license of Meagan Nozzarella, R.N., to practice as a professional nurse in the Commonwealth of Virginia, be, and are hereby, TERMINATED.

Pursuant to § 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as a public record and shall be made available for public inspection or copying on request.

Pursuant to § 54.1-2400(10) of the Code, Ms. Nozzarella may, not later than 5:00 p.m., on December 14, 2015, notify Jay P. Douglas, Executive Director, Board of Nursing, 9960 Mayland Drive, Suite 300, Henrico, Virginia 23233, in writing that she desires a formal administrative hearing before the Board. Upon the filing with the Executive Director of a request for the hearing, this Order shall be vacated.
