### CONSENT ORDER

The Virginia Board of Nursing ("Board") and Sharon D. Wilson-Brooks, C.N.A., as evidenced by her signature hereto, enter into the following Consent Order affecting Ms. Wilson's certificate to practice as a nurse aide and her application for licensure by repeat examination to practice as a practical nurse in Virginia.

The Board adopts the following Findings of Fact and Conclusions of Law.

### **FINDINGS OF FACT**

- Sharon D. Wilson-Brooks, C.N.A., was issued Certificate No. 1401-151222 to practice as a 1. nurse aide by the Virginia Board of Nursing on March 15, 2012. Said certificate is set to expire on March 31, 2014.
- By application received September 19, 2012, Ms. Wilson-Brooks applied for licensure by repeat 2. examination as a practical nurse in the Commonwealth of Virginia. Her primary state of residence is Virginia.
- Ms. Wilson-Brooks has criminal convictions for misdemeanor assault of a police officer and 3. carrying a concealed weapon.
- Ms. Wilson-Brooks failed to reveal the above-referenced convictions on her initial application 4. for licensure by examination as a practical nurse dated September 15, 2011.
- Ms. Wilson-Brooks failed to reveal the above-referenced convictions on her application for 5. certification by examination as a nurse aide dated January 5, 2012.

# **CONCLUSIONS OF LAW**

1. Finding of Fact No. 4 constitutes a violation of § 54.1-3007(1) of the Code of Virginia (1950), as amended ("Code") and 18 VAC 90-20-300(A)(1)(b) of the Regulations Governing the Practice of Nursing.

- 2. Finding of Fact No. 5 constitutes a violation of § 54.1-3007(1) of the Code and 18 VAC 90-25-100(1)(b) of the Regulations Governing Certified Nurse Aides.
  - Ms. Wilson-Brooks otherwise meets the requirements of § 54.1-3020 of the Code. 2.

### CONSENT

Sharon D. Wilson-Brooks, C.N.A., by affixing her signature hereon, agrees to the following:

- She has been advised to seek advice of counsel prior to signing this document; 1.
- She acknowledges that without her consent, no legal action can be taken against her except 2. pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) et seq. of the Code;
- She acknowledges that she has the following rights, among others: the right to an informal 3. fact finding conference before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against her;
  - She waives all such right to an informal conference; 4.
- She admits to the Findings of Fact and Conclusions of Law contained herein and waives her 5. right to contest such Findings of Fact and Conclusions of Law in any subsequent proceeding before the Board:
- She consents to the entry of the following Order affecting her certificate to practice as a nurse 6. aide and her application for licensure by repeat examination to practice as a practical nurse in Virginia.

## **ORDER**

WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Order, and in lieu of further proceedings, hereby ORDERS as follows:

The application of Sharon D. Wilson-Brooks, C.N.A., for licensure by repeat examination as a 1. practical nurse is APPROVED. Upon successful completion of the NCLEX-PN examination, Ms. Wilson-Brooks shall be issued an unrestricted license to practice as a practical nurse in the Commonwealth.

- 2. Ms. Wilson-Brooks is hereby REPRIMANDED.
- 3. Ms. Wilson-Brooks shall maintain a course of conduct in her capacity as a nurse aide and as a practical nurse commensurate with the requirements of § 54.1-3000 et seq. of the Code, the Regulations Governing the Practice of Nursing and the Regulations Governing Certified Nurse Aides.

Pursuant to §§ 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Consent Order shall remain in the custody of the Department of Health Professions as public record and shall be made available for public inspection or copying upon request.
