

**VIRGINIA:**

**BEFORE THE BOARD OF NURSING**

**IN RE: REBECCA L. MAYNOR, R.M.A.**

**ORDER**

In accordance with §§ 2.2-4019, 2.2-4021 and 54.1-2400(10) of the Code of Virginia (1950), as amended ("Code"), an informal conference was conducted on behalf of the Board of Nursing ("Board") on August 19, 2014, in Henrico County, Virginia. Ms. Maynor was not present and was not represented by legal counsel. Nancy K. Durrett, serving as Agency Subordinate for the Board, submitted a Recommended Decision for consideration.

On November 19, 2014, a quorum of the Board met to receive and act upon the Recommended Decision of the Agency Subordinate. Ms. Maynor was not present nor was she represented by legal counsel.

Based upon its review of the Recommended Decision of the Agency Subordinate, the Board makes the following Findings of Fact and Conclusions of Law and issues the following Order.

**FINDINGS OF FACT**

1. Rebecca L. Maynor, R.M.A. was issued Registration No. 0031-005860 to practice as a medication aide by the Virginia Board of Nursing on May 3, 2012. The registration expired on November 13, 2013. Ms. Maynor was issued Certificate No. 1401-130878 to practice as a nurse aide on June 29, 2009. Ms. Maynor's certificate is scheduled to expire on June 30, 2015.

2. By letter dated July 31, 2014, the Board of Nursing sent a Notice of Informal Conference ("Notice") to Ms. Maynor notifying her that an informal conference would be held on August 19, 2014. The Notice was sent by certified and first class mail to 16027 John Quick Road, Quantico, Virginia 22134, the address of record on file with the Board of Nursing. The Notice sent by certified mail was returned to the Board office marked "moved, left no forwarding address." The Notice sent by first class mail was returned to the

Board office marked “unable to forward.” The Agency Subordinate concluded that adequate notice was provided to Ms. Maynor and the informal conference proceeded in her absence.

3. During the course of her employment as a medication aide at The Crossings at Falls Run, Fredericksburg, Virginia, on March 23, 2013, Rebecca L. Maynor failed to perform an evening medication pass for 16 residents. As a result, the residents did not receive their medication. The error was not discovered until the next day. There was no harm to the residents.

4. As a result of the incident, Ms. Maynor resigned from her employment.

5. Ms. Maynor did not respond to the Department of Health Professions Investigator.

### **CONCLUSIONS OF LAW**

Finding of Fact No. 3 constitutes a violation of § 54.1-3007 (2) and (5) of the Code and 18 VAC 90-60-120(2)(l) and (m) and 18 VAC 90-60-110(A)(2) of the Regulations Governing the Registration of Medication Aides.

### **ORDER**

WHEREFORE, it is hereby ORDERED as follows:

1. Rebecca L. Maynor, R.M.A. is hereby REPRIMANDED.


2. Ms. Maynor shall maintain a course of conduct in her capacity as a medication aide commensurate with the requirements of § 54.1-3000 *et seq.* of the Code and the Board of Nursing Regulations.

Pursuant to §§ 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as public record and shall be made available for public inspection or copying upon request.

Since Ms. Maynor failed to appear at the informal conference, this Order shall be considered final. Ms. Maynor has the right to appeal this Order directly to the appropriate Virginia circuit court. As provided by Rule

2A:2 of the Supreme Court of Virginia, Ms. Maynor has thirty (30) days from the date of service (the date she actually received this decision or the date it was mailed to her, whichever occurred first) within which to appeal this decision by filing a Notice of Appeal with Jay P. Douglas, M.S.M., R.N., C.S.A.C., F.R.E., Executive Director, Board of Nursing, at Perimeter Center, 9960 Mayland Drive, Suite 300, Richmond, Virginia 23233. In the event that this decision is served by mail, three (3) days are added to that period.
