CONSENT ORDER

The Virginia Board of Nursing ("Board") and Judy A. Mason, L.P.N., as evidenced by her signature hereto, enter into the following Consent Order affecting Ms. Mason's license to practice practical nursing in Virginia.

The Board adopts the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

- 1. Judy A. Mason, L.P.N. was issued License No. 0002-018119 to practice practical nursing by the Virginia Board of Nursing on April 24, 1973. Said license is set to expire on May 31, 2015. Her primary state of residence is Virginia.
- 2. On April 9, 2014, during the course of her employment as a practical nurse at Friendship Health and Rehab Center, Roanoke, Virginia, Ms. Mason was assisting another nurse in administering medication to residents. She handed medications to the other nurse, who was unfamiliar with the residents on that wing, and who administered them to the wrong patient. Ms. Mason did not observe the medicine being administered to the patient nor did she confirm that the correct patient received the correct medication. The medication included an injection for Lovenox (enoxaparin sodium, Schedule VI), a blood thinner. The patient required additional monitoring for two days.
 - 3. As a result of this incident, Ms. Mason's employment was terminated.

CONCLUSIONS OF LAW

The Board concludes that Finding of Fact No. 2 constitutes a violation of § 54.1-3007(2), (5) and (8) of the Code of Virginia (1950), as amended ("Code"), and 18 VAC-90-20-300(A)(2)(f) of the Regulations Governing the Practice of Nursing ("Regulations").

CONSENT

Judy A. Mason, L.P.N., by affixing her signature hereon, agrees to the following:

- 1. She has been advised to seek advice of counsel prior to signing this document;
- 2. She acknowledges that without her consent, no legal action can be taken against her except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) et seq. of the Code;
- 3. She acknowledges that she has the following rights, among others: the right to an informal fact finding conference before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against her;
 - 4. She waives all such right to an informal conference;
- 5. She admits to the Findings of Fact and Conclusions of Law contained herein and waives her right to contest such Findings of Fact and Conclusions of Law in any subsequent proceeding before the Board;
- 6. She consents to the entry of the following Order affecting her right to practice practical nursing in Virginia.

ORDER

WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Order, and in lieu of further proceedings, hereby ORDERS as follows:

1. Judy A. Mason, L.P.N. is hereby REPRIMANDED.

2. Ms. Mason shall provide evidence within 60 days of entry of the Order that she has completed

the following National Council of State Boards of Nursing ("NCSBN") online course: Medication Errors:

Detection & Prevention.

3. Ms. Mason shall maintain a course of conduct in her capacity as a practical nurse

commensurate with the requirements of § 54.1-3000 et seq. of the Code and the Board of Nursing

Regulations.

4. Any violation of the terms and conditions of this Order or of any law or regulation affecting the

practice of nursing in the Commonwealth of Virginia shall constitute grounds for the suspension or revocation

of the license of Judy A. Mason, L.P.N. and an administrative proceeding shall be convened to determine

whether such license shall be suspended or revoked.

Pursuant to §§ 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in

the custody of the Department of Health Professions as public record and shall be made available for public

inspection or copying upon request.
