CONSENT ORDER

The Virginia Board of Nursing ("Board") and Pamela Renee Brookman Hoke, C.N.A., as evidenced by her signature hereto, enter into the following Consent Order affecting Ms. Hoke's application for reinstatement of her certificate to practice as a nurse aide in Virginia.

The Board adopts the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

1. Pamela Renee Brookman Hoke, C.N.A., was issued Certificate No. 1401-047802 to practice as a nurse aide by the Virginia Board of Nursing on September 24, 1994. Said certificate expired on September 30, 2012.
2. Ms. Hoke submitted an application for reinstatement of her certificate which was received by the Board on May 5, 2014.
3. On November 22, 2010, Ms. Hoke was convicted of concealment/price alteration of merchandise less than \$200, a misdemeanor, in the Circuit Court of the County of Alleghany, Virginia. She was sentenced to 12 months of incarceration, with 11 months suspended, and one year of unsupervised probation.
4. Ms. Hoke has paid all of the associated court costs in the amount of \$857.91.

CONCLUSIONS OF LAW

1. Finding of Fact No. 3 constitutes a violation of § 54.1-3007(4) of the Code of Virginia (1950), as amended ("Code").

2. Ms. Hoke otherwise meets the requirements of 18 VAC 90-25-80(B) of the Regulations Governing Certified Nurse Aides.

CONSENT

Pamela Renee Brookman Hoke, C.N.A., by affixing her signature hereon, agrees to the following:

1. She has been advised to seek advice of counsel prior to signing this document;
2. She acknowledges that without her consent, no legal action can be taken against her except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) *et seq.* of the Code;
3. She acknowledges that she has the following rights, among others: the right to an informal fact finding conference before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against her;
4. She waives all such right to an informal conference;
5. She admits to the Findings of Fact and Conclusions of Law contained herein and waives her right to contest such Findings of Fact and Conclusions of Law in any subsequent proceeding before the Board;
6. She consents to the entry of the following Order affecting her application for reinstatement of her certificate to practice as a nurse aide in Virginia.

ORDER

WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Order, and in lieu of further proceedings, hereby ORDERS as follows:

1. The application of Pamela Renee Brookman Hoke for reinstatement of her certification to practice as a nurse aide is hereby APPROVED. The Board shall issue Ms. Hoke an unrestricted certificate to practice as a nurse aide in the Commonwealth of Virginia.
2. Ms. Hoke is hereby REPRIMANDED.

3. Ms. Hoke shall maintain a course of conduct in her capacity as a certified nurse aide commensurate with the requirements of § 54.1-3000 *et seq.* of the Code and the Board of Nursing Regulations.

Pursuant to §§ 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as public record and shall be made available for public inspection or copying upon request.

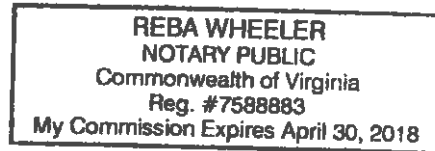
