ORDER

Pursuant to §§ 2.2-4020, 54.1-110 and 54.1-2400(11) of the Code of Virginia (1950), as amended ("Code"), a formal administrative hearing was held before a panel of the Board of Nursing ("Board") on September 15, 2014, in Henrico County, Virginia, to inquire into evidence that Monica Stokes Cooper, C.N.A, may have violated certain laws and regulations governing nurse aide practice and medication aide practice in Virginia. The case was presented by Cynthia E. Gaines, Adjudication Specialist, Administrative Proceedings Division. Erin Barrett, Assistant Attorney General, was present as legal counsel for the Board. Ms. Stokes Cooper was not present and was not represented by legal counsel. The proceedings were recorded by a certified court reporter.

Upon consideration of the evidence presented, the Board adopted the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

- 1. Monica Stokes Cooper, C.N.A., R.M.A., was issued Certificate No. 1401-070789 to practice as a nurse aide in the Commonwealth of Virginia on January 24, 1998. Said certificate expires on January 31, 2015.
- 2. Based upon the representations of Cynthia E. Gaines, Adjudication Specialist, and Commonwealth's Exhibit No. 1, the Notice of Formal Hearing and Affidavit of Mailing, the presiding officer ruled that adequate notice was provided to the respondent and the hearing proceeded in her absence.
- 3. In November 2013, during the course of her employment with Assistance in Living at Atlantic Shores ALF, Virginia Beach, Virginia, Ms. Stokes stole a gift card from Resident A.

CONCLUSIONS OF LAW

The Board concludes that:

- 1. Finding of Fact No. 3 constitutes a violation of § 54.1-3007(2), (5) and (8) of the Code, 18 VAC 90-25-100(2)(h) of the Regulations Governing Certified Nurse Aides.
- 2. Finding of Fact No. 3 and Conclusion of Law No. 1 constitute a finding of misappropriation of patient property pursuant to 42 CFR § 483.156(b)(2) and (c)(1)(iv)(D) of the Code of Federal Regulations.

ORDER

WHEREFORE, the Virginia Board of Nursing, effective upon entry of this Order, hereby ORDERS as follows:

- Certificate No. 1401-070789 issued to Monica Stokes Cooper to practice as a nurse aide in the Commonwealth of Virginia is hereby REVOKED.
 - 2. The certificate of Ms. Stokes Cooper will be recorded as REVOKED and no longer current.
- 3. A finding of misappropriation of patient property shall be ENTERED against Ms. Stokes Cooper in the Virginia Nurse Aide Registry pursuant to 42 CFR § 483.13(C)(1)(ii)(B) and 42 CFR § 483.156(b)(2) and (c)(1)(iv)(D). This finding prohibits Ms. Stokes Cooper's employment as a certified nurse aide in any long-term care facility that receives Medicare or Medicaid reimbursement, according to 42 CFR § 483.13(c)(1)(ii)(B).

Pursuant to §§ 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as public record and shall be made available for public inspection or copying on request.
