ORDER

JURISDICTION AND PROCEDURAL HISTORY

Pursuant to Virginia Code §§ 2.2-4019 and 54.1-2400(10), a Special Conference Committee of

the Virginia Committee of the Joint Boards of Nursing and Medicine ("Committee of the Joint Boards")

held an informal conference on October 11, 2017, in Henrico County, Virginia, to receive and act upon

Sandra Rosado's application for reinstatement of her license to practice as a nurse practitioner in the

Commonwealth of Virginia and to inquire into evidence that grounds may exist to deny said application.

Sandra Marie Rosado, L.N.P., appeared at this proceeding and was represented by Carole

Schriefer, Esquire.

NOTICE

By letter dated September 11, 2017, the Board of Nursing sent a Notice of Informal Conference

("Notice") to Ms. Rosado notifying her that an informal conference would be held on October 11, 2017.

The Notice was sent by certified and first class mail to the legal address of record on file with the Board

of Nursing.

Upon consideration of the evidence, the Committee of the Joint Boards adopts the following

Findings of Fact and Conclusions of Law and issues the Order contained herein.

FINDINGS OF FACT AND CONCLUSIONS OF LAW

1. Sandra Marie Rosado, L.N.P., was issued License Number 0024-167930 to practice as a

nurse practitioner in the area of anesthesiology on July 30, 2008, which was suspended by Order of the

Department of Health Professions pursuant to Virginia Code § 54.1-2409 on December 12, 2013, and continued on indefinite suspension by Order of the Committee of the Joint Boards on October 15, 2014. Ms. Rosado holds an active license to practice as a nurse practitioner in the State of Florida and inactive licenses in the States of Alabama, Arizona, Arkansas, California, Georgia, Maine, Nevada, New Hampshire, New Mexico, North Carolina, Ohio, Pennsylvania, South Carolina, Tennessee, Texas, and West Virginia.

- 2. Ms. Rosado submitted an application for reinstatement of her license on March 7, 2017.
- 3. Sandra Marie Rosado violated Virginia Code § 54.1-3007(2) and 18 VAC 90-30-220(1) of the Regulations Governing the Licensure of Nurse Practitioners in that:
- a. By Order of the Board of Nursing entered on October 15, 2014, Ms. Rosado's application for reinstatement of her nursing license was denied and her license was continued on indefinite suspension, following a formal administrative hearing wherein Ms. Rosado failed to appear and provide evidence in support of her application.
- b. By Consent Agreement with the Ohio Board of Nursing entered July 25, 2015, Ms. Rosado was reprimanded in her capacity as a registered nurse, following the suspension of her Virginia nursing license.
- 4. Ms. Rosado violated Virginia Code §§ 54.1-2915(A)(1) and (5) and 54.1-3007(1) and (7), and 18 VAC 90-30-220(1) and (4) of the Regulations Governing the Licensure of Nurse Practitioners in that:
- a. By Letter of Reprimand dated March 7, 2012, the Arkansas Board reprimanded Ms. Rosado and ordered her to complete the Arkansas Board-approved course, Righting a Wrong: Ethics and Professionalism in Nursing, within six months of receipt of the Letter of Reprimand and submit a two-page summary of the course. This action by the Arkansas Board was based on findings that Ms.

Rosado falsely answered "no" to the question, "Are you under investigation in any state or jurisdiction or has your license been disciplined by any state since your last renewal," on her online applications to renew her license to practice professional nursing and her license to practice as a certified registered nurse anesthetist in the State of Arkansas on March 16, 2011, when, in fact, she had been disciplined by the Nevada Board of Nursing on September 15, 2010.

- b. By Letter of Reprimand signed January 1, 2012, the North Carolina Board of Nursing reprimanded Ms. Rosado for providing false information on the application for renewal of her license to practice nursing in the State of North Carolina, which she submitted on September 21, 2011. Specifically, Ms. Rosado answered "no" to the question regarding whether she had any prior or pending action against a nursing license issued to her from another state since she last renewed in North Carolina that had not been previously reported to the North Carolina Board, when, in fact, she had been disciplined by the Nevada Board of Nursing on September 15, 2010.
- c. By Agreement for Fine accepted and approved on September 15, 2010, the Nevada Board of Nursing issued a fine of \$50.00 to Ms. Rosado and ordered her to complete a Nevada Board-approved four-hour bioterrorism course for falsely attesting that she had completed all mandatory continuing education during the renewal period on a RN/CRNA renewal application she submitted to the Nevada Board on or about February 2, 2010.
- 5. Ms. Rosado provided evidence that her Arkansas license, which was suspended on November 22, 2013, had been reinstated on February 27, 2014.
- 6. Ms. Rosado presented numerous letters of support from physicians and nurses with whom she had worked. She is currently practicing as a nurse practitioner in the area of anesthesiology in Florida and has a supervising physician.

7. Ms. Rosado presented evidence of completion of abundant continuing education,

reflecting her competence to practice.

8. Ms. Rosado stated to the Committee that she now understands and appreciates the

importance of complying with all laws and regulations governing the practice of nursing and nurse

practitioners.

8. Sandra Rosado, L.N.P., has demonstrated that she is able to resume safe and competent

nurse practitioner practice in Virginia.

ORDER

Based on the foregoing Findings of Fact and Conclusions of Law, the Virginia Committee of the

Joint Boards of Nursing and Medicine hereby ORDERS that the application of Sandra Rosado, L.N.P.,

for reinstatement of her license to practice as a nurse practitioner in Virginia is APPROVED. Ms.

Rosado shall be issued an unrestricted license.

Pursuant to Virginia Code §§ 2.2-4023 and 54.1-2400.2, the signed original of this Order shall

remain in the custody of the Department of Health Professions as a public record, and shall be made

available for public inspection and copying upon request.
