NOTICE OF INFORMAL CONFERENCE AND STATEMENT OF ALLEGATIONS

You are hereby notified that an Informal Conference has been scheduled before the Virginia Committee of the Joint Boards of Nursing and Medicine ("Committee of the Joint Boards") regarding your application for reinstatement of your license to practice as a nurse practitioner in the Commonwealth of Virginia following its suspension by the Committee of the Joint Boards.

TYPE OF PROCEEDING:	This is an informal conference before a Special Conference Committee ("Committee") of the Committee of the Joint Boards.

LEGAL AUTHORITY AND JURISDICTION:

- 1. This informal conference is being held pursuant to Virginia Code §§ 2.2-4019 and 54.1-2400(10). This proceeding will be convened as a public meeting pursuant to Virginia Code § 2.2-3700.
- 2. The burden rests on you, as the applicant, to demonstrate that you are prepared to resume safe and competent practice as a nurse practitioner.
- 3. In considering your application, the Committee will consider evidence that grounds exist to deny your application for reinstatement of your license to practice as a nurse practitioner, as more fully set out in the enclosed Statement of Allegations.
- 4. At the conclusion of the proceeding, the Committee is authorized to take any of the following actions:
- Approve your application and issue an unrestricted license to practice as a nurse practitioner.

- Approve your application and issue a reprimand, a monetary penalty, and/or a restricted license subject to terms and conditions.
 - Deny your application;
 - Refer the matter to the Committee of the Joint Boards for a formal administrative hearing.

ABSENCE OF APPLICANT AND APPLICANT'S COUNSEL:

If you fail to appear at the informal conference, the Committee may proceed to hear this matter in your absence and may take any of the actions outlined above.

APPLICANT'S LEGAL RIGHTS:

You have the right to the information on which the Committee will rely in making its decision, to be represented by counsel at this proceeding, to subpoena witnesses and/or documents, and to present relevant evidence on your behalf.

INFORMAL CONFERENCE MATERIALS:

Enclosed is a copy of the documents that will be distributed to the members of the Committee and will be considered by the Committee when discussing any allegations with you and when deliberating on your case. REQUEST FOR A CONTINUANCE

Absent exigent circumstances, such as personal or family illness, a request for a continuance after October 4, 2017, will not be considered. If you obtain counsel, you should do so as soon as possible, as a motion for a continuance due to the unavailability of counsel will not be considered unless received by October 4, 2017.

STATEMENT OF ALLEGATIONS

The Committee of the Joint Boards alleges that grounds exist to refuse to reinstate the license of Sandra Marie Rosado to practice as a nurse practitioner in that:

- 1. Sandra Marie Rosado violated Virginia Code § 54.1-3007(2) and 18 VAC 90-30-220(1) of the Regulations Governing the Licensure of Nurse Practitioners in that:
- a. By Order of the Board of Nursing entered on October 15, 2014, Ms. Rosado's application for reinstatement of her nursing license was denied and her license was continued on indefinite suspension, following a formal administrative hearing wherein Ms. Rosado failed to appear and provide evidence in support of her application.
- b. By Consent Agreement with the Ohio Board of Nursing entered July 25, 2015,
 Ms. Rosado was reprimanded in her capacity as a registered nurse, following the suspension of her Virginia nursing license.
- 2. Ms. Rosado violated Virginia Code §§ 54.1-2915(A)(1) and (5) and 54.1-3007(1) and (7), and 18 VAC 90-30-220(1) and (4) of the Regulations Governing the Licensure of Nurse Practitioners in that:
- a. By Letter of Reprimand dated March 7, 2012, the Arkansas Board reprimanded Ms. Rosado and ordered her to complete the Arkansas Board-approved course, *Righting a Wrong: Ethics and Professionalism in Nursing*, within six months of receipt of the Letter of Reprimand and submit a two page summary of the course. This action by the Arkansas Board was based on findings that Ms. Rosado falsely answered "no" to the question, "Are you under investigation in any state or jurisdiction or has your license been disciplined by any state since your last renewal," on her online applications to renew her license to practice professional nursing and her license to practice as a certified registered

nurse anesthetist in the State of Arkansas on or about March 16, 2011, when, in fact, she had been

disciplined by the Nevada Board of Nursing on September 15, 2010.

b. By Letter of Reprimand signed January 1, 2012, the North Carolina Board of

Nursing reprimanded Ms. Rosado for providing false information on the application for renewal of her

license to practice nursing in the State of North Carolina, which she submitted on or about September

21, 2011. Specifically, Ms. Rosado answered "no" to the question regarding whether she had any prior

or pending action against a nursing license issued to her from another state since she last renewed in

North Carolina that had not been previously reported to the North Carolina Board, when, in fact, she had

been disciplined by the Nevada Board of Nursing on September 15, 2010.

¢. By Agreement for Fine accepted and approved on September 15, 2010, the

Nevada Board of Nursing issued a fine of \$50.00 to Ms. Rosado and ordered her to complete a Nevada

Board-approved four-hour bioterrorism course for falsely attesting that she had completed all mandatory

continuing education during the renewal period on a RN/CRNA renewal application she submitted to

the Nevada Board on or about February 2, 2010.
