CONSENT ORDER

The Virginia Board of Nursing ("Board") and Shareria Hogan, as evidenced by her signature hereto, enter into the following Consent Order affecting Ms. Hogan's application for licensure by examination to practice as a practical nurse in Virginia.

The Board adopts the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

- 1. Shareria Hogan submitted her application for licensure by examination as a practical nurse which was received by the Virginia Board of Nursing on July 24, 2014. Ms. Hogan's primary state of residence is Virginia.
- 2. On July 24, 2014, Ms. Hogan was convicted in the General District Court of Manassas, Virginia, of providing false identification to a police officer and driving on a suspended license. She was ordered to pay fines and costs by October 24, 2014.

CONCLUSIONS OF LAW

- 1. Finding of Fact No. 2 constitutes a violation of § 54.1-3007(4) of the Code of Virginia, as amended ("Code").
 - 2. Ms. Hogan otherwise meets the requirements of § 54.1-3020 of the Code.

CONSENT

Shareria Hogan, by affixing her signature hereon, agrees to the following:

1. Ms. Hogan has been advised to seek advice of counsel prior to signing this document;

- 2. Ms. Hogan acknowledges that without her consent, no legal action can be taken against her except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) et seq. of the Code;
- 3. Ms. Hogan acknowledges that she has the following rights, among others: the right to an informal fact-finding conference before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against her;
 - 4. Ms. Hogan waives all such right to an informal conference;
- 5. Ms. Hogan admits to the Findings of Fact and Conclusions of Law contained herein and waives her right to contest such Findings of Fact and Conclusions of Law in any subsequent proceeding before the Board;
- 6. Ms. Hogan consents to the entry of the following Order affecting her application for licensure to practice as a practical nurse in Virginia.

ORDER

WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Order, and in lieu of further proceedings, hereby ORDERS as follows:

- 1. The application of Shareria Hogan for licensure by examination as a practical nurse is APPROVED. Upon successful completion of the NCLEX-PN examination, Ms. Hogan shall be issued an unrestricted license to practice as a practical nurse in the Commonwealth.
 - 2. Ms. Hogan is hereby REPRIMANDED.
- 3. Ms. Hogan shall maintain a course of conduct in her capacity as a practical nurse commensurate with the requirements of § 54.1-3020 et seq. of the Code and the Regulations Governing the Practice of Nursing.
