CONSENT ORDER

The Virginia Board of Nursing ("Board") and Kimberly R. K. Coslett, C.M.T., as evidenced by her signature hereto, enter into the following Consent Order affecting Ms. Coslett's certificate to practice massage therapy in Virginia.

FINDINGS OF FACT

1. Kimberly R. K. Coslett, C.M.T., was issued Certificate No. 0019-006198 to practice massage therapy by the Virginia Board of Nursing on August 15, 2006. Said certificate is set to expire on August 31, 2015.

2. During an investigation regarding a complaint filed with the Department of Health Professions, the continuing education hours of Ms. Coslett were requested. Ms. Coslett failed to provide evidence indicating she had completed 24 hours of continuing education for the renewal period of 2011 to 2013. Ms. Coslett provided evidence showing only five hours of completed continuing education. At the time of her certificate renewal she attested that she had completed the required continuing education hours.

CONCLUSIONS OF LAW

Finding of Fact No. 2 constitutes a violation of §54.1-3007(2) and (5) of the Code of Virginia, (1950), as amended ("Code"), and 18 VAC 90-50-75(A)(2) and 18 VAC 90-50-90(1)(b) of the Regulations Governing the Certification of Massage Therapists ("Regulations").

CONSENT

Kimberly R. K. Coslett, C.M.T., by affixing her signature hereon, agrees to the following:

1. She has been advised to seek advice of counsel prior to signing this document;
2. She acknowledges that without her consent, no legal action can be taken against her except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) *et seq.* of the Code;
3. She acknowledges that she has the following rights, among others: the right to an informal fact finding conference before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against her;
4. She waives all such right to an informal conference;
5. She admits to the Findings of Fact and Conclusions of Law contained herein and waives her right to contest such Findings of Fact and Conclusions of Law in any subsequent proceeding before the Board;
6. She consents to the entry of the following Order affecting her right to practice massage therapy in Virginia.

ORDER

WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Order, and in lieu of further proceedings, hereby ORDERS as follows:

1. Kimberly R. K. Coslett, C.M.T., is hereby REPRIMANDED.
2. Ms. Coslett shall provide the Board with verification that she has completed 19 hours of continuing education to satisfy the continuing education requirement for the 2011 to 2013 renewal period **within 90 days** of the entry of this Order. Said hours shall not be credited toward the next renewal of her certificate.
3. Ms. Coslett shall maintain a course of conduct in her capacity as a massage therapist commensurate with the requirements of § 54.1-3000 *et seq.* of the Code and the Board of Nursing Regulations.

4. Any violation of the terms and conditions of this Order or of any law or regulation affecting the practice of massage therapy in the Commonwealth of Virginia shall constitute grounds for the suspension or revocation of the certificate of Ms. Coslett and an administrative proceeding shall be convened to determine whether such certificate shall be suspended or revoked.

Pursuant to §§ 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as public record and shall be made available for public inspection or copying upon request.

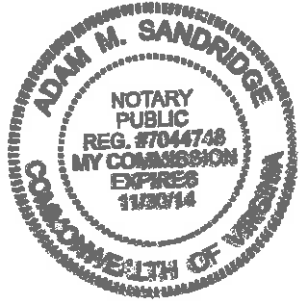
