**ORDER**

Now comes the Virginia Board of Nursing ("Board") and Tamberlyn Russell, C.N.A., R.M.A., as evidenced by the signature affixed below, enter into this Order affecting the certification and registration of Ms. Russell to practice as a certified nurse aide and registered medication aide in the Commonwealth of Virginia.

**FINDINGS OF FACT**

After consideration of the evidence and statements concerning the allegations, the Committee makes the following Findings of Fact:

1. Tamberlyn Russell, C.N.A., R.M.A., was issued certificate No. 1401-060092 to practice as a nurse aide in the Commonwealth of Virginia on June 16, 1996. Said certificate expires on January 31, 2015.
2. Tamberlyn Russell, C.N.A., R.M.A., was issued registration No. 0031-006394 to practice as a medication aide in the Commonwealth of Virginia on December 17, 2012. Said registration expires on December 31, 2014.
3. By an Order entered May 29, 2009 and November 9, 2012, Ms. Russell was subject to certain terms and conditions. One of the terms of this Order was Ms. Russell's compliance with all terms and conditions of her contract with the Health Practitioners' Intervention Program (currently known as the Health Practitioners' Monitoring Program, hereafter "HPMP"), pursuant to Chapter 25.1 of Title 54.1 of the Code of Virginia (1950), as amended, and 18 VAC 76-10-10, et seq., of the Regulations Governing the

HPMP.

4. Ms. Russell has complied with all the terms and conditions of the above Order, and has successfully completed her contract with the HPMP.

#### CONCLUSIONS OF LAW

The Board concludes that Tamberlyn Russell, C.N.A., R.M.A., has met the requirements of the Code of Virginia (1950), as amended, and the Regulations of the Board of Nursing, and the Orders entered May 29, 2009 and November 9, 2012, and this matter is properly before the Board.


#### ORDER

WHEREFORE, on the basis of the foregoing Findings of Fact and Conclusions of Law it is hereby ORDERED that the terms and conditions placed on the certificate and registration of Tamberlyn Russell, C.N.A., R.M.A., to practice as a certified nurse aide and registered medication aide in the Commonwealth of Virginia, be, and are hereby, TERMINATED.

Pursuant to §§ 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as public record and shall be made available for public inspection or copying on request.


