CONSENT ORDER

The Virginia Board of Nursing ("Board") and Annie Washington, as evidenced by her signature hereto, enter into the following Consent Order affecting Ms. Washington's application for reinstatement of her certificate to practice as a nurse aide in Virginia.

FINDINGS OF FACT

- 1. Annie Washington, was issued Certificate No. 1401-008888 to practice as a nurse aide by the Virginia Board of Nursing on June 19, 1989. Said certificate expired on June 30, 2013.
- 2. Ms. Washington submitted an application for reinstatement of her certificate to practice as a nurse aide in Virginia, which was received by the Board on July 9, 2014.
- 3. Ms. Washington was convicted of one count of felony theft of government property in the United States District Court for the Eastern District of Virginia, Norfolk Division, on August 21, 2012. Ms. Washington was sentenced to 16 months imprisonment in the Federal Bureau of Prisons, placed on supervised probation for a period of three years and ordered to pay \$203,604.00 in restitution.

CONCLUSIONS OF LAW

- 1. Finding of Fact No. 3 constitutes a violation of §54.1-3007(4) of the Code of Virginia, (1950), as amended ("Code").
 - 2. Ms. Washington otherwise meets the requirements of §54.1-3023 of the Code.

CONSENT

Annie Washington, by affixing her signature hereon, agrees to the following:

- 1. She has been advised to seek advice of counsel prior to signing this document;
- 2. She acknowledges that without her consent, no legal action can be taken against her except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) et seq. of the Code;
- 3. She acknowledges that she has the following rights, among others: the right to an informal fact finding conference before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against her:
 - 4. She waives all such right to an informal conference;
- 5. She admits to the Findings of Fact and Conclusions of Law contained herein and waives her right to contest such Findings of Fact and Conclusions of Law in any subsequent proceeding before the Board;
- 6. She consents to the entry of the following Order affecting her application for reinstatement of her certificate to practice as a nurse aide in Virginia.

<u>ORDER</u>

WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Order, and in lieu of further proceedings, hereby ORDERS as follows:

- 1. The application of Annie Washington for reinstatement of her certificate to practice as a nurse aide in Virginia is APPROVED.
 - 2. Ms. Washington is hereby REPRIMANDED.
- 3. Ms. Washington shall maintain a course of conduct in her capacity as a nurse aide commensurate with the requirements of § 54.1-3000 et seq. of the Code and the Board of Nursing Regulations.
