CONSENT ORDER

The Virginia Board of Nursing ("Board") and Nancy A.W. Connor, R.N., as evidenced by her signature hereto, enter into the following Consent Order affecting Ms. Connor's license to practice professional nursing in Virginia.

The Board adopts the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

- 1. Nancy A.W. Connor, R.N., was issued License No. 0001-136312 to practice professional nursing by the Virginia Board of Nursing on February 1, 1994. Said license is set to expire on February 28, 2015. Her primary state of residence is Virginia.
- 2. By Order entered June 30, 1998 ("Board's Order"), the Board placed Ms. Connor on probation under certain terms and conditions for not less than two years of employment as a professional nurse. She was prohibited from practicing nursing until she completed a Board-approved refresher course in clinical nursing practice and a course in the administration of medications. Ms. Connor completed these required courses and the Board notified her that she was approved to resume practice in June 2005.
 - Ms. Connor has not practiced nursing since the entry of the Board's Order in 1998.
- 4. Term Nos. 2 and 10 of the Board's Order required Ms. Connor to submit quarterly self-reports. She failed to submit the self-reports due June 30, 2011, June 30, 2012, and June 30, 2013.
- 5. Along with her self-report for the period October December 2013, received by the Board on January 2, 2014, Ms. Connor returned her current license to practice professional nursing.

CONCLUSIONS OF LAW

Finding of Fact No. 4 constitutes a violation of Term Nos. 2 and 10 of the Board's Order.

CONSENT

Nancy A.W. Connor, R.N., by affixing her signature hereon, agrees to the following:

- 1. She has been advised to seek advice of counsel prior to signing this document;
- 2. She acknowledges that without her consent, no legal action can be taken against her except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) et seq. of the Code;
- 3. She acknowledges that she has the following rights, among others: the right to an informal fact finding conference before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against her;
 - 4. She waives all such right to an informal conference;
- 5. She admits to the Findings of Fact and Conclusions of Law contained herein and waives her right to contest such Findings of Fact and Conclusions of Law in any subsequent proceeding before the Board;
- 6. She consents to the entry of the following Order affecting her right to practice professional nursing in Virginia.

ORDER

WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Order, and in lieu of further proceedings, hereby ORDERS as follows:

- 1. Nancy A.W. Connor, R.N., is hereby REPRIMANDED.
- The Board ACCEPTS the VOLUNTARY SURRENDER for INDEFINITE SUSPENSION of Ms. Connor's license to practice professional nursing in the Commonwealth of Virginia.
 - 3. The license will be recorded as suspended and no longer current.

- 4. At such time as Ms. Connor shall petition the Board for reinstatement of her license, an administrative proceeding will be convened to determine whether she is capable of resuming the safe and competent practice of professional nursing. Ms. Connor shall be responsible for any fees that may be required for the reinstatement and renewal of the license prior to issuance of the license to resume practice.
 - 5. This suspension applies to any multistate privilege to practice professional nursing.

Pursuant to §§ 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as public record and shall be made available for public inspection or copying upon request.
