CONSENT ORDER

The Virginia Board of Nursing ("Board") and David A. Cregger, R.N., as evidenced by his signature hereto, enter into the following Consent Order affecting Mr. Cregger's license to practice professional nursing in Virginia.

The Board adopts the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

1. David A. Cregger, R.N. was issued License No. 0001-204504 to practice professional nursing by the Virginia Board of Nursing on November 6, 2006. Said license expired on April 30, 2014. Mr. Cregger's primary state of residence is Virginia.
2. Pursuant to a Consent Order entered with the Board of Nursing on January 3, 2013 ("Board's Order"), Mr. Cregger was placed on probation for 12 months employment as a professional nurse under certain terms and conditions. Term No. 5 of the Board's Order required Mr. Cregger to submit quarterly self reports.
3. Mr. Cregger failed to provide the Board with the quarterly self reports that were due on December 31, 2013, March 31, 2014, and June 30, 2014.
4. When he was contacted by the Board's Compliance Case Manager on February 10, 2014, Mr. Cregger stated that he was currently hospitalized, that he had not practiced as a professional nurse for over a year, and that he was not planning on renewing his license.

CONCLUSIONS OF LAW

The Board finds that Finding of Fact No. 3 constitutes a violation of Term No. 5 of the Board's Order.

CONSENT

David A. Cregger, R.N., by affixing his signature hereon, agrees to the following:

1. He has been advised to seek advice of counsel prior to signing this document;
2. He acknowledges that without his consent, no legal action can be taken against him except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) *et seq.* of the Code;
3. He acknowledges that he has the following rights, among others: the right to an informal fact finding conference before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against him;
4. He waives all such right to an informal conference;
5. He admits to the Findings of Fact and Conclusions of Law contained herein and waives his right to contest such Findings of Fact and Conclusions of Law in any subsequent proceeding before the Board;
6. He consents to the entry of the following Order affecting his right to practice professional nursing in Virginia.

ORDER

WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Order, and in lieu of further proceedings, hereby ORDERS as follows:

1. David A. Cregger, R.N. is hereby REPRIMANDED.
2. The right of David A. Cregger to renew License No. 0001-204504 is INDEFINITELY SUSPENDED.

3. The license will be recorded as suspended.

4. At such time as Mr. Cregger shall petition the Board for reinstatement of his license, an administrative proceeding will be convened to determine whether he is capable of resuming the safe and competent practice of professional nursing. Mr. Cregger shall be responsible for any fees that may be required for the reinstatement and renewal of the license prior to issuance of the license to resume practice.

5. This suspension applies to any multistate privilege to practice professional nursing.

Pursuant to §§ 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as public record and shall be made available for public inspection or copying upon request.

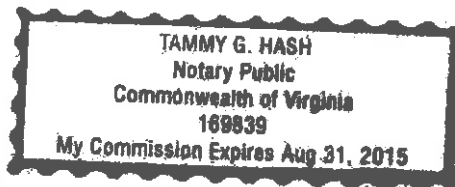
