CONSENT ORDER

The Virginia Board of Nursing ("Board") and Shavaughn Robinson, C.M.T., as evidenced by her signature hereto, enter into the following Consent Order affecting Ms. Robinson's certificate to practice massage therapy in Virginia.

The Board adopts the following Findings of Fact.

FINDINGS OF FACT

- Shavaughn Robinson, C.M.T., was issued Certificate No. 0019-011026 to practice massage therapy by the Virginia Board of Nursing on December 3, 2012. Said certificate is set to expire on May 31, 2014.
- 2. Shavaughn Robinson, C.M.T., was charged with felony murder in the first degree in the Richmond, Virginia Circuit Court on June 5, 2013. Criminal proceedings related to this allegations are pending in the Richmond Circuit Court with a trial scheduled to begin in April 2014.
- 3. Should the Board pursue administrative disciplinary licensure proceedings during the pendency of the criminal allegations, such proceedings may jeopardize Ms. Robinson's exercise of her constitutional rights, including, among others, her right to remain silent pursuant to the 5th Amendment to the United States Constitution, requiring her either to waive such constitutional protection during the Board's administrative proceedings or suffer the loss through revocation of her certificate to practice massage therapy.
- 4. In consideration thereof, the parties agree that in lieu of the Board initiating administrative disciplinary proceedings, Shavaughn Robinson, C.M.T., agrees to the voluntary suspension of her certificate

to practice massage therapy pending the outcome of existing state criminal proceedings in the City of Richmond.

CONSENT

Shavaughn Robinson, C.M.T., by affixing his signature hereon, agrees to the following:

- 1. She has been advised to seek advice of counsel prior to signing this document;
- 2. She acknowledges that without her consent, no legal action can be taken against her except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) et seq. of the Code;
- 3. She acknowledges that she has the following rights, among others: the right to an informal fact finding conference before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against her;
 - 4. She temporarily waives all such right to an informal conference;
- 5. She consents to the entry of the following Order affecting her right to practice massage therapy in Virginia.

<u>ORDER</u>

WHEREFORE, on the basis of the foregoing Findings of Fact and with his consent, the Virginia Board of Nursing hereby agrees to ACCEPT the SURRENDER for Temporary Voluntary SUSPENSION of Shavaughn Robinson's certificate to practice massage therapy in the Commonwealth of Virginia pending the outcome of pending criminal proceedings.

Upon entry of this Consent Order, the certificate of Shavaughn Robinson, C.M.T., will be recorded as suspended and no longer current.

Ms. Robinson may petition the Board for reinstatement of her certificate after the Board has received written confirmation from the appropriate state authorities that any and all criminal matters have been resolved.

Violation of this Consent Order shall constitute grounds for the revocation of the certificate of Shavaughn Robinson, C.M.T. In the event that Ms. Robinson violates any of the terms and conditions of this Consent Order, an administrative hearing shall be convened to determine whether her certificate shall be revoked.

Pursuant to §§ 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as public record and shall be made available for public inspection or copying upon request.
