CONSENT ORDER

The Virginia Board of Nursing ("Board") and Shallanda S. Weathersby, as evidenced by her signature hereto, enter into the following Consent Order affecting Ms. Weathersby's application for certification by endorsement as a nurse aide in Virginia.

The Board adopts the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

- By application received May 30, 2014, Shallanda S. Weathersby applied for certification by endorsement as a nurse aide in the Commonwealth of Virginia. Ms. Weathersby holds certification No. 61271 to practice as a nurse aide in the state of Mississippi. Said license shall expire on March 31, 2015.
- 2. On December 1, 2011, Ms. Weathersby was convicted in the United States District Court for the Southern District of Mississippi, of one count of making false statements, a felony. She was sentenced to two years supervised probation and payment of \$500.00.
 - 3. On November 30, 2013, Ms. Weathersby was released from probation.

CONCLUSIONS OF LAW

- 1. Finding of Fact No. 2 constitutes a violation of § 54.1-3007(4) of the Code of Virginia (1950), as amended ("Code").
 - 2. Ms. Weathersby otherwise meets the requirements of § 54.1-3024 of the Code.

CONSENT

Shallanda S. Weathersby, by affixing her signature hereon, agrees to the following:

- 1. She has been advised to seek advice of counsel prior to signing this document;
- 2. She acknowledges that without her consent, no legal action can be taken against her except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) et seq. of the Code;
- 3. She acknowledges that she has the following rights, among others: the right to an informal fact finding conference before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against her;
 - 4. She waives all such right to an informal conference;
- 5. She admits to the Findings of Fact and Conclusions of Law contained herein and waives her right to contest such Findings of Fact and Conclusions of Law in any subsequent proceeding before the Board;
- 6. She consents to the entry of the following Consent Order affecting her application for certification to practice as a nurse aide in Virginia.

ORDER

WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Consent Order, and in lieu of further proceedings, hereby ORDERS as follows:

- 1. The application of Shallanda S. Weathersby for certification as a nurse aide by endorsement is hereby APPROVED. The Board shall issue Ms. Weathersby an unrestricted certificate to practice as a nurse aide in the Commonwealth of Virginia.
 - 2. Ms. Weathersby is hereby REPRIMANDED.
- 3. Ms. Weathersby shall maintain a course of conduct in her capacity as a nurse aide commensurate with the requirements of § 54.1-3000 et seq. of the Code and the Board of Nursing Regulations.
