**CONSENT ORDER**

The Virginia Board of Nursing ("Board") and Angela Schroeder, L.P.N., as evidenced by her signature hereto, enter into the following Consent Order affecting Ms. Schroeder's license to practice practical nursing in Virginia.

The Board adopts the following Findings of Fact and Conclusions of Law.

**FINDINGS OF FACT**

1. Angela Schroeder, L.P.N., was issued License No. 0002-067101 to practice practical nursing by the Virginia Board of Nursing on September 12, 2003. Said license is set to expire on May 31, 2011.
2. Term No. 1 of an Order of the Board entered December 28, 2005, required Ms. Schroeder to comply with all terms and conditions of the Participation Contract, signed on March 3, 2005, with the Health Practitioners Intervention Program ("HPIP"), for the period specified in the contract. Ms. Schroeder did not comply with the HPIP, as evidenced by the following:
  - a. On June 27, 2005, during the orientation period, Ms. Schroeder submitted a drug screen which was positive for marijuana.
  - b. Ms. Schroeder failed to submit monthly reports.
  - c. Ms. Schroeder failed to submit support group attendance logs after August, 2006.
  - d. Ms. Schroeder failed to call the National Confederation of Professional Services test line after December 6, 2006 to learn of randomly scheduled drug and alcohol screens; Ms. Schroeder missed a urine toxology test on November 15, 2006.

e. Ms. Schroeder failed to enter counseling with the Community Services Board as recommended by the HPIP.

f. Ms. Schroeder was dismissed from the HPIP on or about February 16, 2007, for noncompliance.

### **CONCLUSIONS OF LAW**

Finding of Fact No. 2 (a-f) constitutes a violation of Term No. 1 of the Order of the Board entered December 28, 2005.

### **CONSENT**

Angela Schroeder, L.P.N., by affixing her signature hereon, agrees to the following:

1. She has been advised to seek advice of counsel prior to signing this document;
2. She acknowledges that without her consent, no legal action can be taken against her except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) *et seq.* of the Code;
3. She acknowledges that she has the following rights, among others: the right to an informal fact finding conference before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against her;
4. She waives all such right to an informal conference;
5. She admits to the Findings of Fact contained herein and waives her right to contest such Findings of Fact in any subsequent proceeding before the Board;
6. She consents to the entry of the following Order affecting her right to practice practical nursing in Virginia.

### **ORDER**

WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Order, and in lieu of further proceedings, hereby ORDERS as follows:

1. License No. 0002-067101 of Angela Schroeder, L.P.N., is INDEFINITELY SUSPENDED.
2. The license will be recorded as suspended and no longer current.
3. At such time as Ms. Schroeder shall petition the Board for reinstatement of her license, an administrative proceeding will be convened to determine whether she is capable of resuming the safe and competent practice of practical nursing. Ms. Schroeder shall be responsible for any fees that may be required for the reinstatement and renewal of the license prior to issuance of the license to resume practice.
4. This suspension applies to any multistate privilege to practice practical nursing.

Pursuant to §§ 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as public record and shall be made available for public inspection or copying upon request.
