**NOTICE OF HEARING**

Pursuant to §§ 2.2-4020, 2.2-4024(F), and 54.1-2400(11) of the Code of Virginia (1950), as amended (“Code”), Hayley Troth, L.P.N., who holds License No. 0002-086410 to practice practical nursing in Virginia, which expires on October 31, 2015, is hereby given notice that a formal administrative hearing will be held in the presence of a panel of the Board of Nursing. The hearing will be held on July 14, 2014, at 9:30 a.m., at the offices of the Department of Health Professions, Board of Nursing, Perimeter Center, 9960 Mayland Drive, Suite 201, Henrico, Virginia 23233, at which time Ms. Troth will be afforded the opportunity to be heard in person or by counsel.

At the hearing, Ms. Troth has the following rights, among others: the right to representation by counsel; the right to have witnesses subpoenaed and to present witnesses on her behalf; the right to present documentary evidence; and the right to cross-examine adverse witnesses. If Ms. Troth desires any witnesses to appear on her behalf, she must notify the Director of Administrative Proceedings, Department of Health Professions, 9960 Mayland Drive, Suite 300, Henrico, Virginia 23233, in accordance with the Instructions for Requesting Subpoenas.

The purpose of the hearing is to inquire into evidence that Hayley Troth, L.P.N., may have violated certain laws and regulations governing practical nursing practice in Virginia, as more fully set forth in the Statement of Particulars below.

STATEMENT OF PARTICULARS


The Board alleges that Hayley Troth, L.P.N., may have violated § 54.1-3007(2), (5), and (8) of the Code and 18 VAC 90-20-300(A)(2)(f) of the Regulations Governing the Practice of Nursing in that:

1. On or about April 5, 2013, Resident A, an alert and oriented resident, approached Ms. Troth regarding a breathing treatment. Ms. Troth told the resident that there were other things more important than her, that she had other people to take care of, and Ms. Troth laughed at her and made fun of her to other staff members.

2. On or about April 5, 2013, Ms. Troth told Resident A that she was not going to receive her Ativan until she took a shower, causing the resident to become upset. While Resident A was in the shower, Ms. Troth stated to a staff member that the resident needed to go because she was disgusting.

3. On or about April 1, 2013, Ms. Troth entered the room of a resident where a staff member was providing incontinent care and stated, “can you please shut her the f\*\*\* up,” or words to that effect, in reference to Resident B, who was located in another area. Later during the shift, Ms. Troth repeated the comment in the hallway.
