**CONSENT ORDER**

The Virginia Board of Nursing ("Board") and Jennifer Schuder, as evidenced by her signature hereto, enter into the following Consent Order affecting Ms. Schuder's application for licensure by examination to practice professional nursing in Virginia.

The Board adopts the following Findings of Fact and Conclusions of Law.

**FINDINGS OF FACT**

1. Jennifer Schuder submitted an application for licensure by examination to practice professional nursing in Virginia on March 18, 2013, declaring Virginia as her primary state of residence.
2. On July 15, 2010, in the General District Court of Roanoke County, Virginia, Ms. Schuder was convicted of misdemeanor shoplifting. She was sentenced to 60 days incarceration, with 52 suspended conditioned upon her being of good behavior, and ordered to pay restitution, a fine, and costs.
3. On April 8, 2002, in the Circuit Court of Roanoke County, Virginia, Ms. Schuder was convicted of petit larceny, along with interfering with the property rights of another, both misdemeanors. She was sentenced to 12 months incarceration, which was suspended on the condition that she complete probation, and ordered to pay costs.
4. Ms. Schuder presented evidence that she had satisfied all terms of her criminal convictions.
5. Ms. Schuder was certified as a Nurse Aide in Virginia from December 21, 1993, through December 31, 1995 without any disciplinary action.

**CONCLUSIONS OF LAW**

1. Findings of Fact Nos. 2 and 3 constitute violations of § 54.1-3007(4) of the Code of Virginia (1950), as amended (“Code”).
2. Ms. Schuder otherwise meets the requirements of § 54.1-3017 of the Code.

**CONSENT**

Jennifer Schuder, by affixing her signature hereon, agrees to the following:

1. She has been advised to seek advice of counsel prior to signing this document;
2. She acknowledges that without her consent, no legal action can be taken against her except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) *et seq.* of the Code;
3. She acknowledges that she has the following rights, among others: the right to an informal fact finding conference before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against her;
4. She waives all such right to an informal conference;
5. She admits to the Findings of Fact and Conclusions of Law contained herein and waives her right to contest such Findings of Fact and Conclusions of Law in any subsequent proceeding before the Board;
6. She consents to the entry of the following Order affecting her application for licensure to practice professional nursing in Virginia.

**ORDER**

WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Order, and in lieu of further proceedings, hereby ORDERS as follows:


1. The application of Jennifer Schuder for licensure by examination as a professional nurse is APPROVED. Upon successful completion of the NCLEX-RN examination, Ms. Schuder shall be issued an unrestricted license to practice professional nursing in Virginia.

2. Ms. Schuder is hereby REPRIMANDED.

3. Ms. Schuder shall maintain a course of conduct in her capacity as a professional nurse commensurate with the requirements of § 54.1-3000 *et seq.* of the Code and the Board of Nursing Regulations.

Pursuant to §§ 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as public record and shall be made available for public inspection or copying upon request.



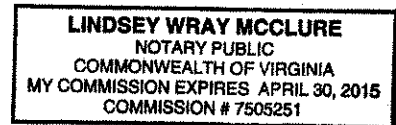
