CONSENT ORDER

The Virginia Board of Nursing, and Bonnie S. Wilmer, L.P.N., with her consent as evidenced by her signature below, enter into the following Consent Order affecting Ms. Wilmer's license to practice nursing in the Commonwealth of Virginia.

FINDINGS OF FACT

1. Bonnie S. Wilmer, L.P.N., holds License No. 0002-018136, issued by the Virginia Board of Nursing, currently set to expire on September 30, 2003.
2. During the course of her employment with Oak Hill Center, Staunton, Virginia, on or about April 11, 2001, in providing care to the alert and oriented Resident A, Ms. Wilmer documented on the Treatment Administration Record that she had done a treatment, when in fact she had failed to perform an ordered bandage change on the heel of the resident's right foot.

CONCLUSIONS OF LAW

The Board concludes that the above Findings of Fact constitute a violation of §§ 54.1-3007(2), and (5) of the Code of Virginia (1950), as amended, and 18 VAC 90-20-300(A)(2)(e) of the Virginia Board of Nursing.

CONSENT

Bonnie S. Wilmer, L.P.N., by affixing her signature hereon, agrees to the following:

2. Ms. Wilmer acknowledges that she is fully aware that without her consent, no legal action can be taken against her except pursuant to the Virginia Administrative Process Act, § 2.2-4000 A, et seq., of the Code of Virginia, 1950, as amended;
 3. Ms. Wilmer acknowledges that she has the following rights among others: the right to an informal fact finding conference before the Board, to reasonable notice of said administrative proceeding, to representation by counsel, and the right to present witnesses and evidence on her behalf;
 4. Ms. Wilmer waives all such right to an informal conference;
 5. Ms. Wilmer admits to the above Findings of Fact;
 6. Ms. Wilmer consents to the entry of the following Order affecting her practice of professional nursing in the Commonwealth of Virginia.

ORDER

WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Consent Order, and in lieu of further proceedings, hereby Orders that Bonnie S. Wilmer, L.P.N., who holds License No. 0002-018136, be and hereby is REPRIMANDED. The Board expects Ms. Wilmer to maintain a course of conduct in her capacity as a practical nurse commensurate with the requirements of Title 54.1, Chapter 30, of the Code of Virginia (1950), as amended, and the Board of Nursing Regulations.

Pursuant to § 2.2-4023 of the Code of Virginia (1950), as amended, the signed original of this Consent Order shall remain in the custody of the Department of Health Professions as public record and shall be made available for public inspection or copying on request.
