# CONSENT ORDER

The Virginia Board of Nursing ("Board") and Tammy Hill, C.N.A., as evidenced by her signature hereto, enter into the following Consent Order affecting Ms. Hill's certificate to practice as a certified nurse aide in Virginia.

The Board adopts the following Findings of Fact and Conclusions of Law.

### FINDINGS OF FACT

- 1. Tammy Hill, C.N.A., was issued Certificate No. 1401-041299 by the Virginia Board of Nursing on December 9, 1993. Said certificate is set to expire on December 31, 2012.
- 2. In November 2011, during an interview for employment with Best Care Home Care, Woodbridge, Virginia, Ms. Hill indicated that she held a license as a professional nurse in Virginia. Upon her hire, Ms. Hill provided a copy of a professional nursing license. The license was for another person named Tammy Hill. The employer noticed discrepancies in the document's information and requested the original from Ms. Hill. Ms. Hill did not produce such a document and had no further contact with Best Care Home Care following her resignation on January 5, 2012.
- 3. Additionally, Ms. Hill indicated in her resume submitted to Best Care Home Care in November, 2011, that she was an EMT-I; however, Ms. Hill holds only an EMT-B credential.
- 4. On January 16, 2012, Ms. Hill submitted an application for employment to LivinRite Home Health, Manassas, Virginia, which also falsely indicated that she held a professional nursing license. After

receiving at least three complaints of Ms. Hill's rude conduct, her employment was terminated on March 19, 2012.

5. Ms. Hill is not currently employed.

#### **CONCLUSIONS OF LAW**

- 1. Findings of Fact Nos. 2 and 4 constitute a violation of §§54.1-3007(2), (3), and (5) and 54.1-3008(4) of the Code of Virgnia (1950), as amended ("Code") and 18 VAC 90-25-100(2)(d) of the Regulations Governing Certified Nurse Aides ("Regulations").
- 2. Finding of Fact No. 3 constitutes a violation of § 54.1-3007(2), (3), and (5) of the Code and 18 VAC 90-25-100(2)(d) of the Regulations.

### **CONSENT**

Tammy Hill, C.N.A., by affixing her signature hereon, agrees to the following:

- 1. She has been advised to seek advice of counsel prior to signing this document;
- 2. She acknowledges that without her consent, no legal action can be taken against her except pursuant to the Virginia Administrative Process Act, §2.2-4000(A) et seq. of the Code;
- 3. She acknowledges that she has the following rights, among others: the right to an informal fact finding conference before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against her;
  - 4. She waives all such right to an informal conference;
- 5. She admits to the Findings of Fact and Conclusions of Law contained herein and waives her right to contest such Findings of Fact and Conclusions of Law in any subsequent proceeding before the Board;
- 6. She consents to the entry of the following Order affecting her right to practice as a certified nurse aide in Virginia.

**ORDER** 

WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of

this Order, and in lieu of further proceedings, hereby ORDERS as follows:

1. Certificate No. 1401-041299 of Tammy Hill, C.N.A., is INDEFINITELY SUSPENDED.

2. The certificate will be recorded as suspended and no longer current.

3. At such time as Ms. Hill shall petition the Board for reinstatement of her certificate, an

administrative proceeding will be convened to determine whether she is capable of resuming the safe and

competent practice as a certified nurse aide. Tammy Hill, C.N.A., shall be responsible for any fees that may

be required for the reinstatement and renewal of the certificate prior to issuance of the certificate to resume

practice.

Pursuant to §§2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in

the custody of the Department of Health Professions as public record and shall be made available for public

inspection or copying upon request.
