**NOTICE OF HEARING**

("Code"), LaToya Wilson, L.P.N., who, prior to its mandatory suspension by the Department of Health

Professions on July 12, 2012, held License No. 0002-073885 to practice as a practical nurse in Virginia, is

23233, at which time Ms. Wilson will be afforded the opportunity to be heard in person or by counsel.

At the hearing, Ms. Wilson has the following rights, among others: the right to representation by

counsel; the right to have witnesses subpoenaed and to present witnesses on her behalf; the right to present

documentary evidence; and the right to cross-examine adverse witnesses. If Ms. Wilson desires any

witnesses to appear on her behalf, she must notify the Director of Administrative Proceedings, Department of

The purpose of the hearing is to receive and act upon Ms. Wilson's application for reinstatement of

Wilson, L.P.N., may have violated certain laws and regulations governing practical nursing practice in

Virginia, as more fully set forth in the Statement of Particulars below.

The burden rests upon Ms. Wilson, as the applicant, to demonstrate that she is capable of resuming the safe and competent practice of practical nursing in Virginia.

The Board alleges that LaToya Wilson, L.P.N., may have violated §54.1-3007(4) of the Code in that on or about June 11, 2012, Ms. Wilson was convicted of three counts of felony obtaining money under false pretense in the Dinwiddie County, Virginia, Circuit Court.
