#### CONSENT ORDER

The Virginia Board of Nursing ("Board") and Denise Dabney, as evidenced by her signature hereto, enter into the following Consent Order affecting Ms. Dabney's application for registration by examination to practice as a medication aide in Virginia.

The Board adopts the following Findings of Fact and Conclusions of Law.

### FINDINGS OF FACT

- 1. Denise Dabney submitted an application for registration by examination to practice as a medication aide which was received by the Board on April 25, 2014.
- 2. On December 18, 2001, Ms. Dabney was convicted of three counts of felony credit card theft, one felony count of credit card fraud, and one felony count of check forgery in the Circuit Court of the County of Henrico, Virginia.
- 3. Ms. Dabney was sentenced to 12 months of incarceration, ordered to \$1,382.00 in restitution and \$2,982.00 in court costs, and placed on supervised probation for ten years.
- 4. Ms. Dabney provided evidence that she has paid the restitution and was released from probation on October 5, 2004. She is currently on a payment plan to pay the court costs associated with her conviction.

## CONCLUSIONS OF LAW

- 1. Finding of Fact No. 2 constitutes a violation of § 54.1-3007(4) of the Code of Virginia (1950), as amended ("Code").
  - 2. Ms. Dabney otherwise meets the requirements of § 54.1-3042 of the Code.

#### CONSENT

Denise Dabney, by affixing her signature hereon, agrees to the following:

- 1. She has been advised to seek advice of counsel prior to signing this document;
- 2. She acknowledges that without her consent, no legal action can be taken against her except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) et seq. of the Code;
- 3. She acknowledges that she has the following rights, among others: the right to an informal fact finding conference before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against her;
  - She waives all such right to an informal conference;
- 5. She admits to the Findings of Fact and Conclusions of Law contained herein and waives her right to contest such Findings of Fact and Conclusions of Law in any subsequent proceeding before the Board;
- 6. She consents to the entry of the following Order affecting her application for registration by examination to practice as a medication aide in Virginia.

#### <u>ORDER</u>

WHEREFORE, it is hereby ORDERED that:

- 1. The application of Denise Dabney for registration by examination to practice as a medication aide is APPROVED. Upon successful completion of the Medication Aide examination, Ms. Dabney shall be issued an unrestricted registration to practice as a medication aide in the Commonwealth.
  - Ms. Dabney is hereby REPRIMANDED.
- 3. Ms. Dabney shall maintain a course of conduct in her capacity as a registered medication aide commensurate with the requirements of § 54.1-3000 et seq. of the Code and the Board of Nursing Regulations.
