<u>ORDER</u>

The Virginia Board of Nursing ("Board") adopts the following Findings of Fact and Conclusions of Law affecting the license of Daniel Burton, R.N., to practice as a professional nurse in Virginia.

FINDINGS OF FACT

- 1. Daniel Burton, R.N., was issued License No. 0001-201393 by the Virginia Board of Nursing on June 21, 2006 to practice as a professional nurse. Said license is set to expire on February 29, 2016. His primary state of residence is Virginia.
- 2. By an Order of the Board entered on July 1, 2014, Mr. Burton was made subject to certain terms and conditions. One of the terms of this Order was Mr. Burton's compliance with all terms and conditions of his contract with the Health Practitioners' Monitoring Program ("HPMP"), pursuant to Chapter 25.1 of Title 54.1 of the Code of Virginia (1950), as amended, and 18 VAC 76-10-10, et seq., of the Regulations Governing the HPMP.
- 3. Mr. Burton has complied with all terms and conditions of the above Order and has successfully completed his contract with the HPMP.

CONCLUSIONS OF LAW

The Board concludes that Daniel Burton, R.N., has met the requirements of the Code of Virginia (1950), as amended, the Regulations of the Board of Nursing, and the Order entered on July 1, 2014, and that this matter is properly before the Board.

ORDER

WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Order and in lieu of further proceedings, hereby ORDERS that the terms and conditions regarding Daniel Burton's license be TERMINATED and that he be issued an unrestricted license to practice professional nursing in the Commonwealth of Virginia.

Mr. Burton shall maintain a course of conduct in his capacity as a professional nurse commensurate with the requirements of § 54.1-3000 et seq. of the Code and the Regulations Governing the Practice of Nursing.

Pursuant to § 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as a public record and shall be made available for public inspection or copying upon request.

Pursuant to § 54.1-2400(10) of the Code, Mr. Burton may, not later than 5:00 p.m., on August 5, 2014, notify Jay P. Douglas, M.S.M., R.N., C.S.A.C., F.R.E., Executive Director, Board of Nursing, 9960 Mayland Drive, Suite 300, Henrico, Virginia 23233, in writing that he desires a formal administrative hearing before the Board. Upon the filing with the Executive Director of a request for the hearing, this Order shall be vacated.
