CONSENT ORDER

The Virginia Board of Nursing ("Board") and Maiwa Barre, as evidenced by her signature hereto, enter into the following Consent Order affecting Ms. Barre's application for licensure by examination as a professional nurse in Virginia.

The Board adopts the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

1. Maiwa Barre submitted an application for licensure by examination as a professional nurse, which was received by the Board on March 29, 2014, and she declared Virginia as her primary state of residence.
2. On September 20, 2010, Ms. Barre was convicted in the Fairfax County, Virginia, General District Court, Virginia, of petty larceny, a misdemeanor involving moral turpitude.
3. Ms. Barre has paid all fines and costs associated with this conviction.

CONCLUSIONS OF LAW

The Board concludes that:

1. Finding of Fact No. 2 constitutes a violation of § 54.1-3007(4) of the Code of Virginia (1950), as amended ("Code").
2. Ms. Barre otherwise meets the qualifications of § 54.1-3017 of the Code.

CONSENT

Maiwa Barre, by affixing her signature hereon, agrees to the following:

1. She has been advised to seek advice of counsel prior to signing this document;

2. She acknowledges that without her consent, no legal action can be taken against her except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) *et seq.* of the Code;

3. She acknowledges that she has the following rights, among others: the right to an informal fact finding conference before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against her;

4. She waives all such right to an informal conference;

5. She admits to the Findings of Fact and Conclusions of Law contained herein and waives her right to contest such Findings of Fact and Conclusions of Law in any subsequent proceeding before the Board;

6. She consents to the entry of the following Order affecting her application for licensure by examination as a professional nurse in Virginia.

ORDER

WHEREFORE, it is hereby ORDERED as follows:

1. The application of Maiwa Barre for licensure by examination as a professional nurse is APPROVED. Upon successful completion of the NCLEX-RN examination, Ms. Barre shall be issued an unrestricted license to practice as a professional nurse in the Commonwealth.

2. Ms. Barre is hereby REPRIMANDED.

3. Ms. Barre shall maintain a course of conduct in her capacity as a professional nurse commensurate with the requirements of § 54.1-3000 *et seq.* of the Code and the Board of Nursing Regulations.

Pursuant to §§ 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as public record and shall be made available for public inspection or copying upon request.
