CONSENT ORDER

The Virginia Board of Nursing ("Board") and Angelina Calubaquib, R.M.A., as evidenced by her signature hereto, enter into the following Consent Order affecting Ms. Calubaquib's registration to practice as a medication aide in Virginia.

The Board adopts the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

1. Angelina Calubaquib, R.M.A. was issued Registration No. 0031-003194 to practice as a medication aide by the Virginia Board of Nursing on July 20, 2009. Said registration is set to expire on May 31, 2015. She also holds a certificate to practice as a nurse aide in Virginia, which is scheduled to expire in January 2015. Additionally, she is licensed by the Board of Long-Term Care Administrators to practice as an Assisted Living Facility Administrator-in-Training.
2. During the course of her ownership and employment with Golden Years and More assisted living facility, Manassas, Virginia:
 - a. On December 26, 2013, Ms. Calubaquib did not begin administering residents' scheduled 10:00 a.m. medications until 11:00 a.m. All medications were administered to residents more than one hour after their ordered time.
 - b. On December 26, 2013, Ms. Calubaquib allowed an unlicensed staff member to administer medication to a resident but documented that she herself administered the medication.

c. On several occasions in December 2013, Ms. Calubaquib provided skilled wound care to a resident, which is beyond the scope of practice of medication aides.

CONCLUSIONS OF LAW

1. Finding of Fact No. 2(a) constitutes a violation of § 54.1-3007(2) and (5) of the Code of Virginia (1950), as amended (“Code”), and 18 VAC 90-60-110(A)(2) and (B)(2) and 18 VAC 90-60-120(2)(l) and (m) of the Regulations Governing the Registration of Medication Aides (“Regulations”).
2. Finding of Fact No. 2(b) constitutes a violation of § 54.1-3007(2) and (5) of the Code and 18 VAC 90-60-120(2)(d) of the Regulations.
3. Finding of Fact No. 2(c) constitutes a violation of § 54.1-3007(2) and (5) of the Code and 18 VAC 90-60-120(2)(a) of the Regulations.

CONSENT

Angelina Calubaquib, R.M.A., by affixing her signature hereon, agrees to the following:

1. She has been advised to seek advice of counsel prior to signing this document;
2. She acknowledges that without her consent, no legal action can be taken against her except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) *et seq.* of the Code;
3. She acknowledges that she has the following rights, among others: the right to an informal fact finding conference before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against her;
4. She waives all such right to an informal conference;
5. She admits to the Findings of Fact and Conclusions of Law contained herein and waives her right to contest such Findings of Fact and Conclusions of Law in any subsequent proceeding before the Board;

6. She consents to the entry of the following Order affecting her right to practice as a medication aide in Virginia.


ORDER

WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Order, and in lieu of further proceedings, hereby ORDERS as follows:

1. Angelina Calubaquib, R.M.A. is hereby REPRIMANDED.
2. Ms. Calubaquib shall maintain a course of conduct in her capacity as a medication aide commensurate with the requirements of § 54.1-3000 *et seq.* of the Code and the Board of Nursing Regulations.

Pursuant to §§ 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as public record and shall be made available for public inspection or copying upon request.

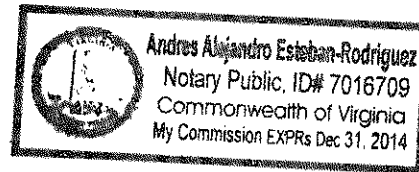
