CONSENT ORDER

The Virginia Board of Nursing ("Board") and Tia L. McCoy, as evidenced by her signature hereto, enter into the following Consent Order affecting Ms. McCoy's application for reinstatement of her certificate to practice as a nurse aide in the Commonwealth of Virginia.

The Board adopts the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

1. Tia L. McCoy was issued Certificate No. 1401-086934 to practice as a nurse aide by the Virginia Board of Nursing on June 14, 2001. Said certificate expired on June 30, 2003.
2. On April 11, 2014, the Board received Ms. McCoy's application for reinstatement of her certificate.
3. On July 14, 2010, Ms. McCoy was convicted in the General District Court for the City of Norfolk, Virginia, of one count of concealment of merchandise, a misdemeanor involving moral turpitude. She was sentenced to six months incarceration, with five months and 20 days suspended, she was placed on probation for 24 months, she was ordered to complete 25 hours of community service, and she was ordered to pay a \$500.00 fine and \$215.00 in costs.
4. All fines and costs were paid and she was released from probation by February 21, 2012.
5. Ms. McCoy has not performed nursing related activities for compensation in over two years.

CONCLUSIONS OF LAW

1. Finding of Fact No. 3 constitutes a violation of § 54.1-3007(4) of the Code of Virginia (1950), as amended ("Code").

2. Ms. McCoy otherwise meets the requirements of reinstatement of her nurse aide certificate.

CONSENT

Tia L. McCoy, by affixing her signature hereon, agrees to the following:

1. She has been advised to seek advice of counsel prior to signing this document;
2. She acknowledges that without her consent, no legal action can be taken against her except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) *et seq.* of the Code;
3. She acknowledges that she has the following rights, among others: the right to an informal fact finding conference before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against her;
4. She waives all such right to an informal conference;
5. She admits to the Findings of Fact and Conclusions of Law contained herein and waives her right to contest such Findings of Fact and Conclusions of Law in any subsequent proceeding before the Board;
6. She consents to the entry of the following Order affecting her application for reinstatement of her certificate to practice as a nurse aide in Virginia.

ORDER


WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Order, and in lieu of further proceedings, hereby ORDERS as follows:

1. The application of Tia L. McCoy for reinstatement of her certification to practice as a nurse aide is hereby APPROVED. Upon successful completion of the National Nurse Aide Assessment Program examination, the Board shall issue Ms. McCoy an unrestricted certificate to practice as a nurse aide in the Commonwealth of Virginia.
2. Ms. McCoy is hereby REPRIMANDED.

3. Ms. McCoy shall maintain a course of conduct in her capacity as a nurse aide commensurate with the requirements of § 54.1-3000 *et seq.* of the Code and the Board of Nursing Regulations.


