ORDER

Pursuant to §§ 2.2-4019, 2.2-4021, and 54.1-2400(10) of the Code of Virginia (1950), as amended (“Code”), a Special Conference Committee (“Committee”) of the Virginia Board of Nursing (“Board”) met on June 5, 2014 in Henrico County, Virginia, to receive and act upon the evaluation of Valencia Hayes, L.P.N. as required in the Order of the Board entered on September 4, 2013. Ms. Hayes was present and was not represented by counsel.

Upon consideration of the evidence, the Committee adopts the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

1. Valencia Hayes, L.P.N. was issued License No. 0002-080032 to practice practical nursing in the Commonwealth of Virginia on March 27, 2009. Said license is scheduled to expire on December 31, 2014. Her primary state of residence is Virginia.
2. By letter dated May 2, 2014, the Board sent a Notice of Informal Conference (“Notice”) by certified and first class mail to Ms. Hayes notifying her that an Informal Conference would be held on June 5, 2014. The Notice was sent to 4051 Falstone Drive, Richmond, Virginia 23234, the address of record on file with the Board.
3. By Order entered September 4, 2013 (“Board’s Order”), the Board required Ms. Hayes to have an evaluation by a mental health/chemical dependency specialist satisfactory to the Board and to have a written report of the evaluation submitted to the Board.

4. Ms. Hayes had the required evaluation, which was submitted to the Board on December 26, 2013. The evaluation revealed no conditions that require further action or monitoring by the Board.

CONCLUSIONS OF LAW

Ms. Hayes has complied with the Board's Order and this matter is properly before the Board.

ORDER

On the basis of the foregoing, the Committee hereby ORDERS as follows:

1. The Committee shall TAKE NO FURTHER ACTION and the terms imposed on the license of Valencia Hayes, L.P.N. are terminated.

2. Ms. Hayes shall maintain a course of conduct in her capacity as a practical nurse commensurate with the requirements of § 54.1-3000 *et seq.* of the Code and the Board of Nursing Regulations.

Pursuant to §§ 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as public record and shall be made available for public inspection or copying on request.

Pursuant to Section 54.1-2400(10) of the Code, Ms. Hayes may, not later than 5:00 p.m., on July 21, 2014, notify Jay P. Douglas, M.S.M., R.N., C.S.A.C., F.R.E., Executive Director, Board of Nursing, 9960 Mayland Drive, Suite 300, Henrico, Virginia 23233, in writing that she desires a formal administrative hearing before the Board. Upon the filing with the Executive Director of a request for the hearing, this Order shall be vacated.
