<u>ORDER</u>

The Virginia Board of Nursing ("Board") enters the following Order affecting the license of

Kimberly Blair, L.P.N. to practice practical nursing in Virginia.

The Board adopts the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

1. Kimberly Blair, L.P.N. was issued License No. 0002-046549 to practice practical nursing by

the Virginia Board of Nursing on October 21, 1992. Said license is set to expire on January 31, 2016. Ms.

Blair also held a license to practice practical nursing in the State of Idaho, which is expired. Her primary

state of residence is Virginia.

2. By Order entered December 27, 2013, the Board required Ms. Blair to complete two NCSBN

online courses and to undergo a mental health evaluation and have a written report of the evaluation

submitted to the Board.

3. Ms. Blair submitted verification that she had completed the required NCSBN courses.

4. Ms. Blair had an evaluation by a licensed professional counselor and a report of said

evaluation was received by the Board on March 31, 2014.

5. The evaluation revealed no conditions that require further action or monitoring by the Board.

CONCLUSIONS OF LAW

Ms. Blair has complied with the Board's Order and this matter is properly before the Board.

ORDER

WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Order, and in lieu of further proceedings, hereby ORDERS as follows:

- 1. The Board hereby releases Kimberly Blair, L.P.N. from monitoring.
- 2. Ms. Blair shall maintain a course of conduct in her capacity as a practical nurse commensurate with the requirements of § 54.1-3000 et seq. of the Code and the Board of Nursing Regulations.

Pursuant to §§ 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as public record and shall be made available for public inspection or copying upon request.
