ORDER

The Virginia Board of Nursing ("Board") enters the following Order affecting the license of Cristin

Banton, L.P.N. to practice practical nursing in Virginia.

The Board adopts the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

1. Cristin Banton, L.P.N. was issued License No. 0002-084859 to practice practical nursing by

the Virginia Board of Nursing on May 25, 2011. Said license is set to expire on September 30, 2014. Ms.

Banton also held a license to practice practical nursing in the State of North Carolina, which expired in 2012.

Her primary state of residence is Arizona.

2. By Order entered November 25, 2013, the Board required Ms. Banton to undergo a mental

health evaluation and to have a written report of the evaluation submitted to the Board.

3. Ms. Banton had an evaluation by a licensed professional counselor in the State of Arizona and

a report of said evaluation was received by the Board on February 12, 2014.

4. The evaluation revealed no conditions that require further action or monitoring by the Board.

CONCLUSIONS OF LAW

Ms. Banton has complied with the Board's Order and this matter is properly before the Board.

<u>ORDER</u>

WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Order, and in lieu of further proceedings, hereby ORDERS as follows:

- 1. The Board hereby releases Cristin Banton, L.P.N. from monitoring.
- 2. Ms. Banton shall maintain a course of conduct in her capacity as a practical nurse commensurate with the requirements of § 54.1-3000 et seq. of the Code and the Board of Nursing Regulations.

Pursuant to §§ 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as public record and shall be made available for public inspection or copying upon request.
