incorporated by reference herein.

WHEREUPON, pursuant to its authority under § 54.1-2408.1(A) of the Code, the Board concludes that a

substantial danger to public health or safety warrants this action and ORDERS that the license of Dorothy M.

Evans, R.N., License No. 0001-128972 to practice professional nursing in the Commonwealth of Virginia is

hereby SUSPENDED. It is further ORDERED that a hearing be convened forthwith to receive and act upon

evidence in this case and that the Executive Director of the Board shall be authorized to execute this Order and

all other documents, notices and orders on behalf of the Board necessary to bring this matter to a hearing.

Upon entry of this Order, the license of Dorothy M. Evans, R.N., will be recorded as suspended and no

longer current.

This Order shall be applicable to Ms. Evans' multistate licensure privilege, if any, to practice professional

nursing.

Pursuant to § 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the

Department of Health Professions as a public record and shall be made available for public inspection or

copying on request.

NOTICE OF HEARING

Pursuant to §§ 2.2-4020, 2.2-4024(F), and 54.1-2400(11) of the Code of Virginia (1950), as amended

("Code"), Dorothy M. Evans, who, prior to its summary suspension by the Board of Nursing on February 19,

2014, held License No. 0001-128972 to practice professional nursing in Virginia, which was set to expire on

September 30, 2014, is hereby given notice that a formal administrative hearing will be held in the presence

of a panel of the Board of Nursing. The hearing will be held on March 20, 2014, at 2:00 p.m., at the offices

of the Department of Health Professions, Board of Nursing, Perimeter Center, 9960 Mayland Drive, Suite

201, Henrico, Virginia 23233, at which time Ms. Evans will be afforded the opportunity to be heard in

person or by counsel.

At the hearing, Ms. Evans has the following rights, among others: the right to representation by

counsel; the right to have witnesses subpoenaed and to present witnesses on her behalf; the right to present

documentary evidence; and the right to cross-examine adverse witnesses. If Ms. Evans desires any witnesses

to appear on her behalf, she must notify the Director of Administrative Proceedings, Department of Health

Professions, 9960 Mayland Drive, Suite 300, Henrico, Virginia 23233, in accordance with the Instructions

for Requesting Subpoenas.

The purpose of the hearing is to inquire into evidence that Ms. Evans may have violated certain laws

governing professional nursing practice in Virginia, as more fully set forth in the Statement of Particulars

below.

STATEMENT OF PARTICULARS

The Board alleges that Dorothy M. Evans, R.N., may be in violation of § 54.1-3007(6) of the Code in that she may be unable to safely practice professional nursing due to mental illness, as evidenced by Ms. Evans' involuntary admission to Eastern State Hospital, Williamsburg, Virginia, on or about October 1, 2013, pursuant to a court order on the grounds that Ms. Evans was incompetent to stand trial for criminal charges and her diagnosis of "Bipolar Disorder, Manic, severe with psychotic features."
