CONSENT ORDER

The Virginia Board of Nursing ("Board") and Kihana Sanders, L.P.N., as evidenced by her signature hereto, enter into the following Consent Order affecting Ms. Sanders' license to practice practical nursing in Virginia.

The Board adopts the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

1. Kihana Sanders, L.P.N., was issued License No. 0002-080763 to practice practical nursing by the Virginia Board of Nursing on July 21, 2009. Said license is set to expire on October 31, 2014. Ms. Sanders was previously licensed as a C.N.A. in Virginia; that license expired on September 30, 2009. Ms. Sanders' primary state of residence is Virginia.
2. During the course of her employment with Maxim Healthcare Services, Ms. Sanders submitted duplicate flow sheets for a patient for the dates of September 16, 2013 and September 17, 2013. The flow sheets contained different clinical data for the same time periods. Ms. Sanders stated that she thought the flow sheets had been lost and she recreated them from memory.
3. Ms. Sanders' employment with Maxim Healthcare Services was terminated in October, 2013.

CONCLUSIONS OF LAW

Finding of Fact No. 2 constitutes a violation of §54.1-3007(2) and (5) of the Code of Virginia (1950), as amended ("Code"), and 18 VAC 90-20-300(A)(2)(e) of the Regulations Governing the Practice of Nursing.

CONSENT

Ms. Kihana Sanders, L.P.N., by affixing her signature hereon, agrees to the following:

1. She has been advised to seek advice of counsel prior to signing this document;
2. She acknowledges that without her consent, no legal action can be taken against her except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) *et seq.* of the Code;
3. She acknowledges that she has the following rights, among others: the right to an informal fact finding conference before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against her;
4. She waives all such right to an informal conference;
5. She admits to the Findings of Fact and Conclusions of Law contained herein and waives her right to contest such Findings of Fact and Conclusions of Law in any subsequent proceeding before the Board;
6. She consents to the entry of the following Order affecting her right to practice practical nursing in Virginia.

ORDER

WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Order, and in lieu of further proceedings, hereby ORDERS as follows:

1. Kihana Sanders, L.P.N. is hereby REPRIMANDED.
2. Ms. Sanders shall maintain a course of conduct in her capacity as a licensed practical nurse commensurate with the requirements of § 54.1-3000 *et seq.* of the Code and the Board of Nursing Regulations.

Pursuant to §§ 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in

the custody of the Department of Health Professions as public record and shall be made available for public inspection or copying upon request.
