ORDER OF SUMMARY SUSPENSION

WHEREUPON, pursuant to its authority under § 54.1-3009 of the Code of Virginia (1950), as amended, the Board concludes that a substantial danger to public health or safety warrants this action and ORDERS that the license of Stephanie S. Solomon to practice practical nursing in the Commonwealth of Virginia be and hereby is SUSPENDED. It is further ORDERED that a hearing be convened forthwith to receive and act upon evidence in this cause and that the Executive Director of the Board shall be authorized to execute this Order and all other documents, notices and orders on behalf of the Board necessary to bring this matter to hearing.

Pursuant to § 9.6.14:14 of the Code of Virginia (1950), as amended, the signed original of this Order shall remain in the

custody of the Department of Health Professions as public record and shall be made available for public inspection or copying on request.

NOTICE OF HEARING

Pursuant to § 9-6.14:12, § 54.1-110 and § 54.1-2400(9) of the Code of Virginia (1950), as amended, ("the Code"), you are hereby given notice that, pursuant to § 9-6.14:14.1(F), a hearing will be held in the presence of a panel of the Board of Nursing ("the Board"). The hearing will be held at 8:30 a.m., on January 24, 1996, at the offices of the Department of Health Professions, 6606 West Broad Street, Fourth Floor, Richmond, Virginia, at which time you will be afforded the opportunity to be heard in person or by counsel.

At the hearing you have the following rights, among others: the right to representation by counsel, the right to have witnesses subpoenaed and to present witnesses on your behalf, the right to present documentary evidence and the right to cross-examine adverse witnesses. If you desire any witnesses to appear on your behalf, notify the Executive Director of the Board of Nursing, 6606 West Broad Street, Fourth Floor, Richmond, Virginia 23230-1717, giving the names and address of the witnesses, at least fifteen (15) days prior to the date of the hearing in order that subpoenas may be issued.

The purpose of the hearing is to receive and act upon evidence that you may have violated certain laws and regulations governing the practice of nursing in Virginia, as more fully set forth in the Statement of Particulars below.

STATEMENT OF PARTICULARS

The Board alleges that Stephanie Sisson Solomon, has violated § 54.1-3007(2), (5), (6) and (8) of the Code of Virginia (1950), as amended, and § 4.1.A.2(c), (e) and (f) of the Board of Nursing Regulations, in that:

- Between March 11, 1994, and March 24, 1994, Ms. Solomon received inpatient treatment for depression at St. Albans Psychiatric Hospital, Radford, Virginia.
- Since August 3, 1995, Ms. Solomon has received outpatient psychiatric treatment from Howard M. Lebow, M.D., for depression.
- During the course of her employment with Friendship Manor Health Care Center, Roanoke, Virginia, between August 28, 1995, and October 7, 1995:

#3 and Lortab, Schedule III controlled substances, and Darvocet N-100, a Schedule IV controlled

substance, for her personal and unauthorized use. She accomplished this diversion by falsifying

By her own admission, Ms. Solomon diverted various controlled substances, to include: Tylenol

records, in that she signed out and documented as administered to residents more medication than

actually administered.

a.

b. On October 5, 1995, Ms. Solomon diverted Nubain, a Schedule VI controlled substance, for her

personal and unauthorized use.

c. On or about October 5, 1995, Ms. Solomon failed to provide patient care as ordered, in that she

failed to change the dressings of five (5) residents during her shift.

4. By her own admission, for approximately two years prior to October 1995, Ms. Solomon has abused

prescribed pain medication, and has used marijuana and abused alcohol.

5. By her own admission, Ms. Solomon also self-administered Tylenol #3 and Darvocet N-100, which she

had obtained from her boyfriend's prescription bottles.

6. On or about October 10, 1995, Ms. Solomon entered Mt. Regis Treatment Center, Salem, Virginia, for

chemical dependency treatment.

7. During the course of her employment with Richfield Nursing Center, Salem, Virginia:

a. On April 5, 1995, Ms. Solomon was counseled for failure to follow through with a physician's

orders.

b. On April 25, 1994, August 24, 1994, October 7, 1994, March 24, 1995, July 25, 1995, and

August 7, 1995, Ms. Solomon was counseled for excessive tardiness or absenteeism. As a result,

her employment was terminated effective August 7, 1995.
