<u>AMENDED ORDER</u>

The Virginia Board of Nursing ("Board") adopts the following Findings of Fact and Conclusions of

Law affecting the license of Stacey Rexrode, L.P.N., to practice as a practical nurse in Virginia.

FINDINGS OF FACT

1. Stacey Rexrode, L.P.N., was issued License No. 0002-049325 to practice as a practical nurse

by the Virginia Board of Nursing on May 11, 1994. Said license expires on November 30, 2015. Her

primary state of residence is Virginia.

2. By an Order of the Board entered on April 25, 2013, Ms. Rexrode was reprimanded and

ordered to have a mental health and chemical dependency evaluation by a mental health/chemical

dependency specialist satisfactory to the Board within 45 days from the date the Order was entered, with the

reports being due on June 9, 2013. This action was due to findings that Ms. Rexrode received Vicodin

(Schedule III) from a co-worker for her personal and unauthorized use during the course of her employment

with Avante of Waynesboro, Waynesboro, Virginia, and due to findings that her employment with the Brian

Center, Fincastle, Virginia, was terminated in June 2011, for inappropriate behavior and sleeping on the job.

3. Mr. Rexrode requested and received two extensions until August 22, 2013. A third extension

request was denied by the Board on October 24, 2013.

4. On November 12, 2013, the Board received the chemical dependency evaluation report, and

on November 18, 2013, the Board received the mental health evaluation report.

<u>CONCLUSIONS OF LAW</u>

1. This matter is properly before the Board.

2. Stacey Rexrode, L.P.N., has complied with the terms and conditions of the Board's Order, and no further action is required of her by the Board.

## <u>ORDER</u>

WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Order, and in lieu of further proceedings, hereby ORDERS that the terms and conditions regarding Stacey Rexrode's license be TERMINATED and that she be issued an unrestricted license to practice practical nursing in the Commonwealth of Virginia.

Ms. Rexrode shall maintain a course of conduct in her capacity as a practical nurse commensurate with the requirements of § 54.1-3000 et seq. of the Code and the Regulations Governing the Practice of Nursing.

Pursuant to §§ 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as public record and shall be made available for public inspection or copying upon request.
