NOTICE OF INFORMAL CONFERENCE BEFORE AN AGENCY SUBORDINATE

Dear Ms. Ward:

This letter is official notification that an informal conference of the Virginia Board of Nursing ("Board") will be held on **January 7**, **2014**, **at 10:30 a.m.**, at the Department of Health Professions, Perimeter Center, 9960 Mayland Drive, Suite 201, Henrico, Virginia. In accordance with §§ 2.2-4019, 2.2-4021, and 54.1-2400(10) of the Code of Virginia (1950), as amended ("Code"), this informal conference will be held before an agency subordinate of the Board of Nursing. This informal conference will be convened as a public meeting pursuant to § 2.2-3700 et seq. of the Code. The agency subordinate will inquire into allegations that you may have violated certain laws and regulations governing nurse aide practice in Virginia.

Specifically:

- 1. You may have violated § 54.1-3007(2), (3), (5), and (8) of the Code and 18 VAC 90-25-100(2)(h) of the Regulations Governing Certified Nurse Aides ("Regulations") in that:
- a. On or about April 10, 2013, during the course of your employment with Waddell Nursing and Rehabilitation Center, Galax, Virginia, you stole approximately \$40.00 from Client A's wallet.

- b. On or between July 22, 2013 and August 24, 2013, during the course of your employment with Interim Healthcare, Wytheville, Virginia, while providing in-home care to Client B, you used the client's debit card to make unauthorized ATM withdrawals totaling approximately \$3,000.00.
- 2. You may have violated § 54.1-3007(2) and (3) of the Code and 18 VAC 90-25-100(2)(d) of the Regulations in that you falsified the following employment applications:
 - a. On an application for employment with Interim Healthcare, dated May 18, 2013:
- i. You falsely indicated that your reason for leaving Waddell Nursing and Rehabilitation Center was "miscommunication (will explain)," when, in fact, your employment was terminated for stealing money from Client A as referenced above.
- ii. You falsely indicated that your reason for leaving Golden Living Nursing Blue Ridge, Galax, Virginia, was "personal problems," when, in fact, your employment was terminated as referenced above.
- iii. You failed to reveal your prior employment with Grayson Nursing and Rehabilitation Center, and your reason for leaving.
- b. On an application for employment with Waddell Nursing and Rehabilitation Center, dated March 8, 2013:
- i. You falsely indicated that your reason for leaving Golden Living Nursing was "will discuss." When asked by staff for clarification, you indicated that you left because your son was sick for an extended time, and you were let go. However, your employment was terminated on or about December 20, 2012, due to misconduct.
- ii. You falsely indicated that your reason for leaving Grayson Nursing and Rehabilitation Center was "didn't agree with the way they conducted themselves," when, in fact, your employment was terminated on or about June 8, 2012, due to absences during your probationary period. When asked by staff for clarification, you stated that you left due to excessive gossiping, and that you needed a change.
- c. On an application for employment with Golden Living Center, dated July 17, 2012, you failed to reveal your prior employment with Grayson Nursing and Rehabilitation Center, and your reason for leaving.

In its deliberations, the agency subordinate may use the Sanction Reference Points System, as contained in the Sanction Reference Manual. The manual, which is a guidance document of the Board, may be accessed at http://www.dhp.virginia.gov/nursing. Please click on *Guidance Documents*, then select #90-7. You may also request a paper copy from the Board office by calling (804) 367-4515.

After consideration of all information, the agency subordinate may:

- If the agency subordinate finds that there is insufficient evidence to warrant further action or that the charges are without foundation, notify you by mail that your record has been cleared of any charge which might affect your right to practice as a nurse aide in the Commonwealth;
- Recommend findings of fact, conclusions of law and a sanction, to include a reprimand, placing you on probation with terms, suspension or revocation of your certificate, or imposing a monetary penalty pursuant to § 54.1-2401 of the Code.

Further, the agency subordinate may refer this matter for a formal administrative proceeding pursuant to § 2.2-4020 of the Code.

If the agency subordinate finds that there is sufficient evidence to find you in violation of the above charge(s) and § 54.1-3007(8) of the Code, the agency subordinate shall recommend that the Board make a finding of abuse, neglect, or misappropriation of patient property, which will be entered in the Virginia Nurse Aide Registry pursuant to 42 CFR § 483.156(b)(2) and (c)(1)(iv)(D) of the Code of Federal Regulations. According to 42 CFR § 483.13(c)(1)(ii)(B), such a finding will prohibit your future employment as a certified nurse aide in any long term care facility that receives Medicare or Medicaid reimbursement.

Board's Review of Agency Subordinate's Recommended Decision

If you appear in person or by counsel at the informal conference, the recommendation of the agency subordinate will be presented to a quorum of the Board. The Board may accept or modify the recommendation, or reject the recommendation and move the case to formal hearing. If you do not agree with the decision of the Board, you have the right to a formal administrative hearing before the Board.

If you fail to appear in person or by counsel at the informal conference, the recommendation of the agency subordinate will be presented to a quorum of the Board. The Board may accept or modify the recommendation, or reject the recommendation. The Board's decision regarding the agency subordinate's recommendation is a final order that can only be appealed to circuit court as provided by Rule 2A:2 of the Supreme Court of Virginia.

You have the right to information that will be relied upon by the agency subordinate in making a decision. Therefore, I enclose a copy of the documents that will be distributed to the agency subordinate, and will be considered when discussing the allegations with you and when deliberating upon your case. These documents are enclosed <u>only</u> with the original notice sent by certified mail, which you may be required to claim at the post office. Please bring these documents with you to the informal conference.

To facilitate this proceeding, you should submit five copies of any documents you wish the agency subordinate to consider to the Board of Nursing, Perimeter Center, 9960 Mayland Drive, Suite 300, Richmond, VA 23233, by December 31, 2013. Your documents may not be submitted by facsimile or email.

You may be represented by an attorney at the informal conference. If you obtain counsel, you should do so as soon as possible, because absent good cause to support a request for a continuance, the informal conference will be held on **January 7**, **2014**. A request to continue this proceeding must state **in detail** the reason for the request and must establish good cause. Such request must be made, in writing, to me at the address listed on this letter and must be received by 12 noon on December 31, 2013. Only one such motion will be considered. Absent critical circumstances, such as personal or family illness, a request for a continuance after De will not be considered.
