NOTICE OF HEARING

Pursuant to §§ 2.2-4020, 2.2-4024(F), and 54.1-2400(11) of the Code of Virginia (1950), as amended ("Code"), Dorothy M. Anderton, R.N., who, prior to its suspension by the Board of Nursing on August 15, 2013, held License No. 0001-062713 to practice professional nursing in Virginia, is hereby given notice that a formal administrative hearing will be held in the presence of a panel of the Board of Nursing. The hearing will be held on January 26, 2015, at 9:00 a.m., at the offices of the Department of Health Professions, Board of Nursing, Perimeter Center, 9960 Mayland Drive, Suite 201, Henrico, Virginia 23233, at which time Ms.

Anderton will be afforded the opportunity to be heard in person or by counsel.

At the hearing, Ms. Anderton has the following rights, among others: the right to representation by

counsel; the right to have witnesses subpoenaed and to present witnesses on her behalf; the right to present

documentary evidence; and the right to cross-examine adverse witnesses. If Ms. Anderton desires any

witnesses to appear on her behalf, she must notify the Director of Administrative Proceedings, Department of

Health Professions, 9960 Mayland Drive, Suite 300, Henrico, Virginia 23233, in accordance with the

Instructions for Requesting Subpoenas.

The purpose of the hearing is to inquire into evidence that Dorothy M. Anderton, R.N., may have

violated certain terms and conditions imposed on her as set forth in the Order of the Board entered on May

30, 2014, and to inquire into evidence that she may have violated certain laws governing professional

nursing practice in Virginia, as more fully set forth in the Statement of Particulars below.

STATEMENT OF PARTICULARS

The Board alleges that Dorothy M. Anderton, R.N., may have violated § 54.1-3007(6) of the Code and Term No. 5 of the Order entered May 30, 2014, which required her to enter into and comply with all terms and conditions of the Health Practitioners' Monitoring Program ("HPMP"), in that on or about July 18, 2014, Ms. Anderton was dismissed from the HPMP due to noncompliance. Specifically:

- 1. Ms. Anderton tested positive for alcohol on May 28, 2014 and June 17, 2014. Ms. Anderton subsequently reported drinking two liters of wine on June 14, 15 and 20, 2014.
- 2. Ms. Anderton failed to call the drug screen test line on July 2, 2014 and stopped calling on July 7, 2014.
 - 3. Ms. Anderton failed to enter residential treatment as recommended.
