NOTICE OF HEARING

Pursuant to §§ 2.2-4020, 2.2-4024(F), and 54.1-2400(11) of the Code of Virginia (1950), as amended

("Code"), Deborah H. Bradley, who, prior to its suspension by the Board of Nursing on February 25, 2002,

held License No. 0001-066306 to practice professional nursing in Virginia, is hereby given notice that a

formal administrative hearing will be held in the presence of a panel of the Board of Nursing. The hearing

will be held on May 21, 2014, at 11:00 a.m., at the offices of the Department of Health Professions, Board of

Nursing, Perimeter Center, 9960 Mayland Drive, Suite 201, Henrico, Virginia 23233, at which time Ms.

Bradley will be afforded the opportunity to be heard in person or by counsel.

At the hearing, Ms. Bradley has the following rights, among others: the right to representation by

counsel; the right to have witnesses subpoenaed and to present witnesses on her behalf; the right to present

documentary evidence; and the right to cross-examine adverse witnesses. If Ms. Bradley desires any

witnesses to appear on her behalf, she must notify the Director of Administrative Proceedings, Department of

Health Professions, 9960 Mayland Drive, Suite 300, Henrico, Virginia 23233, in accordance with the

Instructions for Requesting Subpoenas.

The purpose of the hearing is to receive and act upon Ms. Bradley's application for reinstatement of

her license to practice professional nursing in Virginia and to inquire into evidence that Ms. Bradley may

have violated certain laws and regulations governing nursing practice in Virginia.

The burden rests upon Ms. Bradley, as the applicant, to demonstrate that she is capable of resuming the

safe and competent practice of professional nursing in Virginia.

STATEMENT OF PARTICULARS

The Board alleges that Deborah H. Bradley may have violated § 54.1-3007(1) and (6) of the Code and 18 VAC 90-20-300(A)(1)(b) of the Regulations Governing the Practice of Nursing in that on her application for reinstatement of her license to practice professional nursing, she answered "NO" to the question "Do you have a mental, physical, or chemical dependency condition which could interfere with your current ability to practice nursing?" when, in fact, by her own admission, Ms. Bradley has applied for disability and has been diagnosed with fibromyalgia, cervical lumbar and spine disease and chronic fatigue syndrome.
