License No.: 0002-079280****AMENDED CONSENT ORDER**

By letter dated April 10, 2014, the Virginia Board of Nursing ("Board") noticed Brandi Pryor, L.P.N., for a formal hearing. In lieu of proceeding to a formal hearing, the Board and Ms. Pryor, as evidenced by their signatures affixed below, agree to enter into this Consent Order affecting the license of Ms. Pryor to practice practical nursing in Virginia.

The Board adopts the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

1. Brandi Pryor, L.P.N., was issued License No. 0002-079280 to practice practical nursing by the Virginia Board of Nursing on October 20, 2008. Said license was summarily suspended by Order of the Board entered April 10, 2014. Ms. Pryor's primary state of residence is Virginia.
2. On October 4, 2013, Ms. Pryor suffered a psychotic episode while off duty at Sentara Village - Chesapeake, Chesapeake, Virginia, where she presented in a disheveled and incoherent condition with her infant son, and wrongfully attempted to remove a resident from the facility, placing her son and the resident in danger. She was subsequently arrested following the incident and placed in the Chesapeake City Jail. On November 14, 2013, Ms. Pryor was admitted to Central State Hospital, Petersburg, Virginia, on a criminal temporary detention order after being found in her jail cell acting in a bizarre manner. Ms. Pryor was unable to assist with her intake evaluation. The evaluation documented that Ms. Pryor was suffering from either major depression with psychotic features or bipolar disorder.

CONCLUSIONS OF LAW

Finding of Fact No. 2 constitutes a violation of § 54.1-3007(6) of the Code of Virginia (1950), as amended ("Code").

CONSENT

Brandi Pryor, L.P.N., by affixing her signature hereon, agrees to the following:

1. She has been advised to seek advice of counsel prior to signing this document;
2. She acknowledges that without her consent, no legal action can be taken against her except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) *et seq.* of the Code;
3. She acknowledges that she has the following rights, among others: the right to a formal fact finding hearing before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against her;
4. She waives all such right to a formal hearing;
5. She admits to the Findings of Fact and Conclusions of Law contained herein and waives her right to contest such Findings of Fact and Conclusions of Law in any subsequent proceeding before the Board;
6. She consents to the entry of the following Order affecting her right to practice practical nursing in Virginia.

ORDER

WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Order, and in lieu of further proceedings, hereby ORDERS as follows:

1. The Board ACCEPTS the VOLUNTARY SURRENDER for INDEFINITE SUSPENSION of Brandi Pryor's license to practice practical nursing in the Commonwealth of Virginia.
2. The license will be recorded as suspended and no longer current.



3. At such time as Ms. Pryor shall petition the Board for reinstatement of her license, an administrative proceeding will be convened to determine whether she is capable of resuming the safe and competent practice of practical nursing. Ms. Pryor shall be responsible for any fees that may be required for the reinstatement and renewal of the license prior to issuance of the license to resume practice.

4. This suspension applies to any multistate privilege to practice practical nursing.

Pursuant to §§ 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as public record and shall be made available for public inspection or copying upon request.

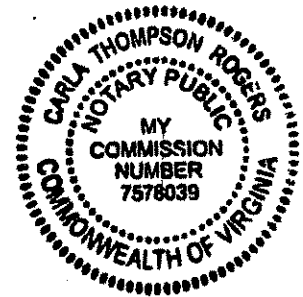
