Dear Mr. Carpenter:

Pursuant to Section 54.1-2409 of the Code of Virginia (1950), as amended, ("Code"), you are hereby given notice that your license to practice nursing in the Commonwealth of Virginia has been mandatorily suspended by the enclosed Order entered March 6, 2006. You are hereby advised that, pursuant to Section 54.1-2409.1 of the Code, any person who practices a profession or occupation after having their license or certificate to do so suspended shall be guilty of a felony.

Section 54.1-2409 of the Code further provides that you may apply to the Board of Nursing ("Board") for reinstatement of your license, and shall be entitled to a hearing not later than the next regular meeting of the Board after the expiration of thirty days from the receipt of such reinstatement application. You have the following rights, among others: to be represented by legal counsel, to have witnesses subpoenaed on your behalf, to present documentary evidence and to cross-examine adverse witnesses. The reinstatement of your license shall require the affirmative vote of three-fourths of the members present of the Board of Nursing.

**ORDER**

In accordance with Section 54.1-2409 of the Code of Virginia (1950), as amended, ("Code"), I, Robert A. Nebiker, Director of the Virginia Department of Health Professions, received and acted upon evidence that the license of Anthony Shane Carpenter, L.P.N., to practice nursing in the State of Ohio, was suspended by Notice of Automatic Suspension and Opportunity for Hearing dated March 18, 2005. A certified copy of the Notice of Automatic Suspension and Opportunity for Hearing (with attachment) is attached to this Order and is marked as Commonwealth's Exhibit No. 1. Further, by Corrected Order entered July 22, 2005, the Ohio Board of Nursing suspended Mr. Carpenter's license to practice nursing for an indefinite period of time, but not less than three (3) years retroactive to March, 2005. A certified copy of the Corrected Order is attached to this Order and is marked as Commonwealth's Exhibit No. 2.

WHEREFORE, by the authority vested in the Director of the Department of Health Professions pursuant to Section 54.1-2409 of the Code, it is hereby ORDERED that the license of Anthony Shane Carpenter, L.P.N., to practice nursing in the Commonwealth of Virginia be, and hereby is, SUSPENDED.

Upon entry of this Order, the license of Anthony Shane Carpenter, L.P.N., will be recorded as suspended and no longer current. Should Mr. Carpenter seek reinstatement of his license pursuant to Section 54.1-2409 of the Code, he shall be responsible for any fees that may be required for the reinstatement and renewal of his license prior to issuance of his license to resume practice.

Pursuant to Sections 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as a public record and shall be made available for public inspection and copying upon request.


