CONSENT ORDER

The Virginia Board of Nursing ("Board") and Karen Helmandollar, L.P.N., as evidenced by her signature hereto, enter into the following Consent Order affecting Ms. Helmandollar's license to practice practical nursing in Virginia.

The Board adopts the following Findings of Fact and Conclusions of Law.

FINDINGS OF FACT

1. Karen Helmandollar, L.P.N., was issued License No. 0002-073273 to practice practical nursing by the Virginia Board of Nursing on April 14, 2006. Said license expired on February 28, 2013. Her primary state of residence is Virginia.
2. By Order of the Board entered September 21, 2012 ("Board's Order"), Ms. Helmandollar was required to pay a monetary penalty of \$100.00 within 30 days of the entry of said Order.
3. Ms. Helmandollar was more than two months late in submitting her check for \$100.00. Her payment arrived on December 30, 2013.

CONCLUSIONS OF LAW

Finding of Fact No. 3 constitutes a violation of Term No. 2 of the Board's Order.

CONSENT

Karen Helmandollar, L.P.N., by affixing her signature hereon, agrees to the following:

1. Ms. Helmandollar has been advised to seek advice of counsel prior to signing this document;

2. Ms. Helmandollar acknowledges that without her consent, no legal action can be taken against her except pursuant to the Virginia Administrative Process Act, § 2.2-4000(A) *et seq.* of the Code;

3. Ms. Helmandollar acknowledges that she has the following rights, among others: the right to an informal fact-finding conference before the Board, the right to reasonable notice of said hearing, the right to representation by counsel, and the right to cross-examine witnesses against her;

4. Ms. Helmandollar waives all such right to an informal conference;

5. Ms. Helmandollar admits to the Findings of Fact and Conclusions of Law contained herein and waives her right to contest such Findings of Fact and Conclusions of Law in any subsequent proceeding before the Board;

6. Ms. Helmandollar consents to the entry of the following Order affecting her right to practice practical nursing in Virginia.

ORDER

WHEREFORE, on the basis of the foregoing, the Virginia Board of Nursing, effective upon entry of this Order, and in lieu of further proceedings, hereby ORDERS as follows:

1. Karen Helmandollar, L.P.N., is hereby REPRIMANDED.

2. Ms. Helmandollar shall maintain a course of conduct in her capacity as a practical nurse commensurate with the requirements of § 54.1-3000 *et seq.* of the Code and the Board of Nursing Regulations.

Pursuant to §§ 2.2-4023 and 54.1-2400.2 of the Code, the signed original of this Order shall remain in the custody of the Department of Health Professions as public record and shall be made available for public inspection or copying upon request.
